If you have not received a copy of a court order suspending your case within 28 days of submitting this completed form, contact the Clerk of District Court at 402-593-4479 to inquire about the status of your request.

Note: In the event that the Judge/Referee *declines* to approve of an order suspending your child support, the matter may be scheduled for hearing before the court, in order for more evidence to be produced. If this occurs, you will receive a Notice in the mail of your hearing date.
