Please allow 10 working days to have the form submitted to the Judge for approval.** You will receive a copy of any court order entered to terminate your child support case. If you have not received a copy of a court order terminating your case within 28 days of submitting this completed form, contact the Clerk of District Court at 402-593-4479 to inquire about the status of your request. *(Note: If mailing this form, include a money order. Cash should NOT be mailed.)*
