Minutes of Meeting of Board of Trustees
June 17, 2009

A meeting of the Board of Trustees of Sanitary and Improvement District No. 52 of Sarpy County, Nebraska, was convened in open and public session beginning at 4:00 p.m. on the 17th day of June, 2009 at the offices of Werner Enterprises, I-80 and Highway 50, Omaha, Nebraska. Present were: Richard S. Reiser, Robert E. Synowicki, Jr., Gregory L. Werner, and Daniel R. Young. Gale L. Wickersham was absent.

Notice of the meeting was given in advance thereof by publication in The Papillion Times on June 11, 2009, a copy of the Proof of Publication being attached to these Minutes. Notice of the meeting was simultaneously given to all members of the Board of Trustees, and their Acknowledgements of Receipt of Notice are attached to these Minutes. Notice has also been given to the County Clerk. Availability of the agenda was communicated in the published Notice and in the Notice to the Trustees of the meeting. A copy of the agenda is attached to these Minutes. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public.

The following proceedings were had:

The Chairman publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

The Chairman announced that the first matter for consideration was the approval of the Minutes from the meeting held on March 11, 2009. After a review and discussion of the Minutes, the minutes were unanimously approved.

The Chairman announced that the next matter for consideration was the engagement of Infinity CPA Group LLC for accounting services to be provided to the District for the year ending June 30, 2009. The Chairman informed the Board that the Chairman had received a letter outlining the accountants' duties and responsibilities in connection with the year-end and annual budget. The letter also included an estimate of fees. The Chairman informed the Board that he would execute the letter acknowledging the District's understanding of the proposal. He informed the Board that it would be appropriate to approve the execution of the proposal on behalf of the District. After thorough discussion, and upon motion duly made, seconded and by roll call vote as follows:

The Board of Trustees authorized the employment of Infinity CPA Group LLC as accountants for the District on the terms set forth in the accountant's proposal, and the Chairman's execution of the proposal on behalf of the District is hereby approved and confirmed.

The Chairman announced that the next matter for consideration was the completion of the project known as Paving Maintenance 2008 Project, which was authorized by the Board at its meeting on September 15, 2008. H & R Construction Company was awarded the contract as the low bidder of the project in the amount of \$49,726.50 at the board meeting on October 9, 2008. The Chairman announced that the Clerk had presented a Certificate from Lamp Rynearson & Associates, engineers for the District, certifying that the all of the work for Paving Maintenance 2008 Project had been completed in accordance with the contract documents. The engineers further certified that the balance due on the contract was \$31,994.00. The Chairman presented a final statement from the engineers requesting a final

payment of \$31,994.00. The Chairman announced that it would be appropriate for the Board to consider accepting the work performed by the contractor and authorizing a final payment in the amount of \$31,994.00. After thorough discussion, and upon motion duly made, seconded and by roll call vote as follows, the following resolution was unanimously adopted.

RESOLVED, that under the provisions of *Neb. Rev. Stat.* § 31-749 and all other applicable provisions of law, the Board of Trustees of Sanitary and Improvement District No. 52 of Sarpy County, Nebraska, do and the same hereby does approve the Certificate of Completion issued by its engineers on June 15, 2009 and does hereby accept the project as complete as certified by its engineers.

The Chairman announced that the next matter for consideration was the ratification of warrants drawn on the General Fund Account of the District and payable to Omaha Public Power District. The Chairman announced that at a prior meeting the Chairman and Clerk were authorized to issue warrants payable to Omaha Public Power District for street lights as they became due to avoid problems caused by payment delays occasioned by delays in meetings. Such warrants are to be ratified at the meeting following their issuance. Warrants were issued as follows:

In addition, the Chairman announced that the next matter for discussion was the consideration of bills to be paid from the General Fund of the District. The Clerk presented a statement from H & R Construction, Inc., along with engineer's recommendation for final payment, in the amount of \$31,994.00 for Paving Maintenance 2008 project, a statement from Suburban Newspapers, Inc. in the amount of \$9.90 for publication expense; statements in the total amount of \$5,487.00 from Lamp Rynearson & Associates for engineering services; a

statement from Omaha Public Power District in the amount of \$290.60 for street lighting; a statement from Commercial Seeding Contractors in the amount of \$297.50, along with engineer's recommendation for payment, for right-of-way mowing; a statement from K.C. Sweeping in the amount of \$380.00 for street sweeping, along with an engineering recommendation; and a statement from Erickson | Sederstrom in the amount of \$1,206.90 for legal fees and costs; upon motion duly made, seconded and by roll call vote as follows:

RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 52 of Sarpy County, Nebraska that the Chairman and Clerk be and they hereby are authorized and directed to execute and deliver Warrant Nos. 2540 through 2559, of the District, dated the date of this meeting, to the following payees and in the following amounts, said Warrants to be drawn on the General Fund of the District and to draw interest at the rate of 7% per annum (interest to be paid when due) and to be redeemed no later than June 17, 2012, subject to extension of said maturity date by order of the District Court of Sarpy County, Nebraska, after notice is given as required by law, to wit:

- A. General Fund Warrant No. 2540 in the amount of \$293.06, payable to Omaha Public Power District;
- B. General Fund Warrant No. 2541 in the amount of \$291.45, payable to Omaha Public Power District;
- C. General Fund Warrant Nos. 2542 through 2551, in increments of \$3,000.00, payable to H & R Construction, Inc.
- D. General Fund Warrant No. 2552 in the amount of \$1,994.00, payable to H & R Construction, Inc.;
- E. General Fund Warrant No. 2553 in the amount of \$9.90, payable to Suburban Newspapers, Inc.;

- F. General Fund Warrant No. 2554 in the amount of \$3,000.00, payable to Lamp Rynearson & Associates, Inc.;
- G. General Fund Warrant No. 2555 in the amount of \$2,487.00, payable to Lamp Rynearson & Associates, Inc.;
- H. General Fund Warrant No. 2556 in the amount of \$290.60, payable to Omaha Public Power District;
- I. General Fund Warrant No. 2557 in the amount of \$297.50, payable to Commercial Seeding Contractors;
- J. General Fund Warrant No. 2558 in the amount of \$380.00, payable to K.C. Sweeping; and
- K. General Fund Warrant No. 2559 in the amount of \$1,206.90, payable to Erickson | Sederstrom, PC.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 52 of Sarpy County, Nebraska that both they and the District hereby find and determine and covenant, and warrant and agree that (a) the facilities for which the above Warrants are issued are designed to serve members of the general public on an equal basis; (b) there are no persons with right to use said facilities other than as members of the general public; (c) ownership and operation of said facilities is with the District or another political subdivision; (d) none of the proceeds of the Warrants will be loaned to any person and to the extent that special assessments have been or are to be levied for any said facilities, such special assessments have been or are to be levied under Nebraska law as a matter of general application to all property specially benefited by such facilities in the District; and (e) the District hereby authorizes and directs the Chairman or Clerk to file, when due, an information reporting form pursuant to Section 149(e) of the Internal Revenue Code of 1986 pertaining to the above Warrants.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 52 of Sarpy County, Nebraska that the District hereby covenants, warrants and agrees as follows: (a) to take all actions necessary under the current federal law to maintain the tax exempt status (as to taxpayers generally) of interest on the above Warrants; and (b) to the extent that it may lawfully do so, the District hereby designates the above Warrants as its "qualified tax exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Internal Revenue

Code of 1986 as amended and covenants and warrants that the District does not reasonably expect to issue warrants or bonds or other obligations aggregating in the principal amount of more than \$5,000,000 during the calendar year in which the above Warrants are to be issued.
