A current copy of the Nebraska Open Meetings Act was available and accessible to members of the public, posted during the Meeting in the room in which such Meeting was held and all in attendance at the Meeting were informed that such copy of the Nebraska Open Meetings Act was available for review and were informed of the location of such copy in the room in which such Meeting was being held. 

PRESENT: Randy Burns, Michael Norris, Jillian Burns, and Kim R. Johnston

ABSENT: None

TIME: 6:30 p.m.

Notice was given in advance thereof by publication in The Times, the designated method for giving notice on October 3, 2012, a copy of the Proof of Publication being attached to these minutes. Notice of this meeting was given to all members of the Board of Trustees, and a copy of their acknowledgment of receipt of notice is attached to these minutes. Availability of the agenda was communicated in the published notice and in the notice to the Trustees of this meeting. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public.

The Clerk publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

The Board had previously been provided with copies of the Sarpy County Election Commissioner's Certificate of Election, a copy of which is attached to these minutes. Elected on Ballot No. 1 were Jillian M. Burns, Kim R. Johnston and Randy Ferris. Elected on Ballot No. 2 were Randy Burns and Michael Norris. The Clerk advised the Board that Randy Ferris had declined to serve as Trustee. Each remaining Trustee took an Oath of Office, which Oaths will be kept with the District's records.

The Clerk advised that Board that due to the declination of Randy Ferris to serve on the Board of Trustees, it was necessary for the remaining Trustees to appoint a resident of the District to fill the vacancy. After some discussion, Don Whittington was nominated to fill said vacancy. The following resolution was duly moved by Jillian Burns and seconded by Michael Norris:

BE IT RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska that Don Whittington is appointed Trustee of the District, to serve until the next election of Trustees or until his/her successor is duly elected and qualified.

The Clerk then stated it was necessary for this newly elected Board to elect two officers, a Chairperson and a Clerk, and stated that the Board should now entertain nominations for the office of Chairperson. Following discussion, Randy Burns was nominated for the office of Chairperson and Jillian Burns was nominated for the office of Clerk. The following resolutions were duly moved by Michael Norris and seconded by Kim R. Johnston:

BE IT RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska that Randy Burns is elected Chairperson of the District, to serve until the next election of Trustees or until his/her successor is duly elected and qualified.

On roll call on the foregoing Resolution the following voted in favor of the same: Jillian Burns, Michael Norris and Kim R. Johnston

Abstaining from the vote was Randy Burns

Thereupon the Chairperson declared the motion carried and said resolution was passed and adopted.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska, that Jillian Burns is elected as Clerk of the District, to serve until the next election of Trustees or until his/her successor is duly elected and qualified.

On roll call on the foregoing Resolution the following voted in favor of the same: Randy Burns, Michael Norris and Kim R. Johnston

Abstaining from the vote was Randy Burns

The following voted nay: None

Thereupon the Chairperson declared the motion carried and said resolution was passed and adopted.

Jillian Burns stated that she would have the attorney for the District check the status of the statutory bonds for the Chairperson and Clerk and file them as required with the County Clerk.

Trustee Randy Burns then offered the following resolution and moved its adoption:

BE IT RESOLVED by the Chairman and Board of Trustees of Sanitary & Improvement District No. 104 of Sarpy County, Nebraska that the approved methods of giving notice of meetings of the Board of Trustees shall be by publication of notice in the Papillion Times, a legal newspaper printed in and of general circulation in Sarpy County, Nebraska, or by posting notice in three places in the District.

Trustee Jillian Burns seconded the motion and on roll call on the foregoing Resolution the following voted in favor of the same: Randy Burns, Michael Norris, Jillian Burns and Kim R. Johnston

The following voted nay: None

Thereupon the Chairperson declared the motion carried and said resolution was passed and adopted.

Randy Burns advised the District with the information he received from the District's engineer with regard to the sink hole at 7108 S. 128th Street.

Randy Burns further advised that Board that numerous attempts had been made to get the property owner at 12713 Deborah Circle to repair the sidewalk in front of their property. The District's engineer had previously determined that the deterioration of the sidewalk was a property owner problem and not that of the District. The attorney for the District had sent a letter to the property owner advising them of the same and requesting them to proceed with getting the necessary repairs completed. The homeowner called the District's attorney and essentially advised that she would not fix it. The repairs have not been completed. Randy Burns had requested that the engineer reexamine the problem just to double check to ensure it was not an issue of the District's and again, his opinion is the issue with regard to the sidewalk have been caused by the property owners. The following resolution was duly moved by Jillian Burns and

seconded by Michael Norris:

BE IT RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska that the District hereby authorize and direct the engineer for the District to contract to have the necessary repairs completed for the sidewalk at 12713 Deborah Circle. The costs of said repairs shall be submitted to the Sarpy County Assessor to be assessed against the property owners and collected in the same manner as other district taxes are assessed, collected and returned.

The Chairperson stated the next order of business to come before the Board was approval of payment to the Trustees for attendance at the monthly meetings of the District for the past year. Jillian Burns introduced the following resolution and moved its adoption:

BE IT FURTHER RESOLVED that the Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska are hereby authorized to received compensation for attendance at monthly meetings of the District at a rate of \$15.00 per meeting, not to exceed \$180.00 as recorded by the Clerk on the Attendance Schedule attached hereto.

Motion seconded by Trustee Randy Burns.

On roll call, the following voted for the passage and adoption of said resolution: Randy Burns, Michael Norris, Jillian Burns and Kim R. Johnston

The following voted NAY: None

Thereupon the Chairperson declared said motion carried and said resolution passed and adopted.

The Chairperson stated the next order of business to come before the Board was the approval of payment of clerk fees for the District for last year, not to exceed \$1,200.00 annually.

Trustee Randy Burns introduced the following resolution and moved for its adoption:

BE IT FURTHER RESOLVED that the Board of Trustees is hereby authorized to issue payment, in the amount of \$1,200.00 to Jillian Burns, the Clerk for the previous year, for services provided the District by such individual.

Motion seconded by Trustee Kim R. Johnston.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska, that both they and the district hereby find and determine and covenant, warrant and agree as follows: the improvements and/or facilities being financed or refinanced by the above Warrants are for essential governmental functions and are designed to serve members of the general public on an equal basis; all said improvements have from the time of their first acquisition and construction been owned, are owned and are to be owned by the District or another political subdivision; to the extent special assessments have been or are to be levied for any of said improvements, such special assessments have been or are to be levied under Nebraska law as a matter of general application to all

property specially benefited by said improvements in the District; the development of the land in the District is for residential or commercial use and the development of the land in the District for sale and occupation by the general public has proceeded and is proceeding with reasonable speed; other than any incidental use of said improvements by a developer during the initial period of development of said improvements, there have been, are and will be no persons with rights to use such improvements other than as members of the general public; none of the proceeds of said Bonds or any refinanced indebtedness have been or will be loaned to any private person or entity; the District hereby authorizes and directs the Chairperson or Clerk to file or cause to be filed, when due, an information reporting form pursuant to Section 149(e) of the Internal Revenue Code of 1986, as amended, pertaining to the above Warrants; and the District does not reasonably expect to sell or otherwise dispose of said improvements and/or facilities, in whole or in part, prior to the last maturity of the above Warrants.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska, that the District hereby covenants, warrants and agrees as follows: (a) to take all actions necessary under current federal law to maintain the tax-exempt status (as to taxpayers generally) of interest in the above warrants; and (b) to the extent that it may lawfully do so, the District hereby designates the above warrants as its "qualified tax-exempt obligations" under Section 265 (b) (3) (B) (i) (III) of the Internal Revenue Code of 1986 as amended and covenants and warrants that the District does not reasonably expect to issue warrants or bonds or other obligations aggregating in the principal amount of more than \$5,000,000 during the calendar year in which the above warrants are to be issued.

BE IT FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 104 of Sarpy County, Nebraska, that this and the preceding resolutions are hereby adopted as the Certificate With Respect to Arbitrage of the District pertaining to the above warrants and the District and the Chairman and Clerk of the District hereby further certify, as of the date of the registration of the above warrants with the County Treasurer of Sarpy County, Nebraska, as follows:

1. No separate reserve or replacement fund has been or will be established with respect to the above warrants. The District reasonably anticipates that monies in its Bond Fund reasonably attributable to the above warrants in excess of the lessor of: (a) 10% of the net principal proceeds of the above warrants, (b) the maximum annual debt service due on the above warrants or (c) 125% of annual debt service due on the above warrants will be expended for payment of principal of an interest on the above warrants within thirteen months after receipt of such monies. That amount which is currently held in the District's Bond Fund which exceeds the amount which is to be expended for payment of principal and interest on the above warrants within thirteen months after receipt of such monies, plus that amount arrived at pursuant to the immediately preceding sentence, will not be invested in any securities or any other investment obligations which bear a yield, as computed in accordance with the actuarial method, in excess of the yield on the above warrants.

2. To the best of their knowledge, information and belief, the above expectations are reasonable.

3. The District has not been notified of any listing of it by the Internal Revenue Service as an issuer that may not certify its bonds.

4. The Certificate is being passed, executed and delivered pursuant to Sections 1.148-2(b)(2) of the Income Tax Regulations under the Internal Revenue Code of 1986, as amended.
