

MINUTES OF MEETING

OF

SANITARY AND IMPROVEMENT DISTRICT NO. 182  
OF SARPY COUNTY, NEBRASKA

A meeting of the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, was convened in open and public session at 10:00 a.m. on the 31st day of July, 2009, at 9412 Giles Road, Papillion, Nebraska.

Present were: John C. Allen, Joyce A. Sramek, Jeanne D. Knox, Edward R. Young and Joseph J. Valenti.

Absent: None.

Notice of the meeting was given in advance thereof by publication in the Bellevue Leader on July 29, 2009, a copy of the proof of publication being attached to these minutes. Notice of this meeting was simultaneously given to all members of the Board of Trustees, and a copy of their acknowledgment of receipt of notice is attached to these minutes. Availability of the agenda was communicated in the published notice and in the notice to the Trustees of this meeting. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public. The agenda was at all times available at the office for the District at 10250 Regency Circle, Suite 300, Omaha, Nebraska 68114.

The Chairman publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

Counsel for the District first presented the Certificate of Results of the Election from the Sarpy County Election Commissioner with respect to the District's election of September 9, 2008. Such certificate indicated that Edward R. Young, Joseph J. Valenti, John C. Allen, Joyce A. Sramek and Jeanne D. Knox had been elected to serve for a two (2) year term for the Board. It was indicated that each of such individuals were owners or designees of owners of real estate within the District boundaries (*as defined by Section 31-727(3) Reissue Rev. Stat. of Neb. 1943*) and, as a consequence, qualified to serve in such capacity. Each individual being in attendance at the meeting indicated a willingness to accept the position of Trustee on the Board.

Discussion was next had with respect to the outstanding matters of the District and the powers and responsibilities of the Board in general. Discussion was also had with respect to the powers and responsibilities of the positions of Chairman and Clerk of the District. Upon conclusion of such discussion, the following roll call vote was taken during which the Trustees: Edward R. Young, Joseph J. Valenti and Jeanne D. Knox voting "Aye", with none voting "Nay", and John C. Allen and Joyce A. Sramek abstaining, thereby adopting and approving the following resolution:

RESOLVED, that John C. Allen be hereby elected to serve in the capacity of Chairman for Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, until the next regularly scheduled election of the Board of Trustees.

FURTHER RESOLVED, that Joyce A. Sramek be hereby elected to serve in the capacity of Clerk for Sanitary and Improvement District No. 182 of

Sarpy County, Nebraska, until the next regularly scheduled election of the Board of Trustees.

There were next presented miscellaneous bills, invoices, statements, and recommendations for the Board's consideration.

There was next presented an invoice from First National Bank of Omaha for paying agent fees in connection with the 2004 bond issue, in the amount of Seven Hundred and no/100 Dollars (\$700.00).

There was next presented correspondence from Lamp, Rynearson & Associates, Inc., engineers for the District, presenting and recommending payment in favor of W. Janssen Construction, Inc. storm sewer maintenance, Invoice No. GB-01-09 in the amount of Nine Thousand Fifty and no/100 Dollars (\$9,050.00).

There was next presented a statement from O'Donnell, Ficene, Wills & Ferdig, LLP, accountants for the District for services rendered to December 31, 2008 for audit of June 30, 2008 financial statements and preparation of the 2008-2009 budget, Invoice No. 54458 in the amount of Four Thousand One Hundred Thirty-Five and 47/100 Dollars (\$4,135.47).

There was next presented a statement from Burr Accounting Services, LLC, for bookkeeping services for the fiscal year ending June 30, 2009, Invoice No. 1213 in the amount of Three Hundred and no/100 Dollars (\$300.00).

There were next presented statements from Lamp, Rynearson & Associates, Inc., engineers for the District for miscellaneous engineering services rendered as follows: (i) through May 23, 2009, Invoice No. 0196016.90-0000004 in the amount of One Hundred and 50/100 Dollars (\$100.50); and (ii) through June 27, 2009, Invoice No. 0196016.90-0000005 in the amount of Three Hundred Sixty-Eight and 49/100 Dollars (\$368.49); said invoices being in the aggregate amount of Four Hundred Sixty-Eight and 99/100 Dollars (\$468.99).

The previously described bills, invoices, recommendations and statements having been presented for the Board's consideration and after review and discussion of such items, the following resolution was duly moved and passed:

RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that the Chairman and Clerk be and they hereby authorized and directed to execute and deliver Warrant No. 312 of the District, dated the date of this meeting, to the following payee and in the following amount, said Warrant to be drawn on the Construction Fund of the District and to draw interest at the rate of seven percent (7%) per annum (interest to be payable on October 10 of each year) and to be redeemed no later than July 31, 2014, subject to extension of said maturity date by order of the District Court of Sarpy County, Nebraska, after notice is given as required by law, to-wit:

Warrant No. 312, for the amount of Seven Hundred and no/100 Dollars (\$700.00), payable to First National Bank of Omaha.

FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that the Chairman and Clerk be and they hereby authorized and directed to execute and deliver Warrant Nos. 313 through 317 of the District, dated the date of this meeting, to the following payees and in the following amounts, said Warrants to be drawn on the General Fund of the District and to draw interest at the rate of seven percent (7%) per annum and to be redeemed

no later than July 31, 2012, subject to extension of said maturity date by order of the District Court of Sarpy County, Nebraska, after notice is given as required by law, to-wit:

Warrant No. 313, for the amount of Five Thousand and no/100 Dollars (\$5,000.00), and Warrant No. 314, for the amount of Four Thousand Fifty and no/100 Dollars (\$4,050.00), payable to W. Janssen Construction, Inc.

Warrant No. 315, for the amount of Four Thousand One Hundred Thirty-Five and 47/100 Dollars (\$4,135.47), payable to O'Donnell, Ficenec, Wills & Ferdig, LLP.

Warrant No. 316, for the amount of Three Hundred and no/100 Dollars (\$300.00), payable to Burr Accounting Services, LLC.

Warrant No. 317, for the amount of Four Hundred Sixty-Eight and 99/100 Dollars (\$468.99), payable to Lamp, Ryneerson & Associates, Inc.

FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that both they and the district hereby find and determine and covenant, warrant and agree as follows: the improvements and/or facilities being financed or refinanced by the above Warrants are for essential governmental functions and are designed to serve members of the general public on an equal basis; all said improvements have from the time of their first acquisition and construction been owned, are owned and are to be owned by the District or another political subdivision; to the extent special assessments have been or are to be levied for any of said improvements, such special assessments have been or are to be levied under Nebraska law as a matter of general application to all property specially benefited by said improvements in the District; the development of the land in the District is for residential or commercial use and the development of the land in the District for sale and occupation by the general public has proceeded and is proceeding with reasonable speed; other than any incidental use of said improvements by a developer during the initial period of development of said improvements, there have been, are and will be no persons with rights to use such improvements other than as members of the general public; none of the proceeds of said Bonds or any refinanced indebtedness have been or will be loaned to any private person or entity; the District hereby authorizes and directs the Chairperson or Clerk to file or cause to be filed, when due, an information reporting form pursuant to Section 149(e) of the Internal Revenue Code of 1986, as amended, pertaining to the above Warrants; and the District does not reasonably expect to sell or otherwise dispose of said improvements and/or facilities, in whole or in part, prior to the last maturity of the above Warrants.

FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that the District hereby covenants, warrants and agrees as follows: (a) to take all actions necessary under current federal law to maintain the tax exempt status (as to taxpayers generally) of interest on the above Warrants; and (b) to the extent that it may lawfully do so, the District hereby designates the above

Warrants as its "qualified tax exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Internal Revenue Code of 1986, as amended, and covenants and warrants that the District does not reasonably expect to issue warrants or bonds or other obligations aggregating in the principal amount of more than \$5,000,000 during the calendar year in which the above Warrants are to be issued.

FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that this and the preceding Resolutions are hereby adopted as the Certificate With Respect to Arbitrage of the District pertaining to the above Warrants and the District and the Chairman and Clerk of the District hereby further certify, as of the date of the registration of the above Warrants with the County Treasurer of Sarpy County, Nebraska, as follows:

1. No separate reserve or replacement fund has been or will be established with respect to the above Warrants. The District reasonably anticipates that monies in its Bond Fund reasonably attributable to the above Warrants in excess of the lesser of: (a) ten percent (10%) of the net principal proceeds of the above Warrants, (b) the maximum annual debt service due on the above Warrants, or (c) one hundred twenty-five percent (125%) of average annual debt service due on the above Warrants will be expended for payment of principal of and interest on the above Warrants within thirteen (13) months after receipt of such monies. That amount which is currently held in the District's Bond Fund which exceeds the amount which is to be expended for payment of principal and interest on the above Warrants within thirteen (13) months after receipt of such monies, plus that amount arrived at pursuant to the immediately preceding sentence, will not be invested in any securities or any other investment obligations which bear a yield, as computed in accordance with the actuarial method, in excess of the yield on the above Warrants.

2. To the best of their knowledge, information and belief, the above expectations are reasonable.

3. The District has not been notified of any listing of it by the Internal Revenue Service as an issuer that may not certify its bonds.

4. This Certificate is being passed, executed and delivered pursuant to Section 1.148-2(b)(2) of the Income Tax Regulations under the Internal Revenue Code of 1986, as amended.

The Clerk then presented for the consideration of the Trustees the One-Call Member Services Agreement for the mandatory membership in the One-Call Notification Center (pursuant to the One Call Notification Act, Neb. Ref. Stat § 76-2301 *et seq*) between the District and Great Plains One Call Service, Inc., dba Digger's Hotline of Nebraska. The Clerk was directed to attach a copy of the Agreement to the minutes of these proceedings. After discussion of the Board, the following resolution was duly moved and seconded and upon a roll call vote the Trustees, John C. Allen, Joyce A. Sramek, Jeanne D. Knox, Edward R. Young and Joseph J. Valenti voted "Aye" with none voting "Nay" thereby passing and adopting the following resolution:


RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 182 of Sarpy County, Nebraska, that the Agreement between the District and Great Plains One Call Service, Inc., dba Digger's Hotline of

Nebraska, concerning the mandatory membership in the One-Call Notification Center (pursuant to the One Call Notification Act, Neb. Ref. Stat § 76-2301 *et seq*), be ratified and approved as proposed.

FURTHER RESOLVED, that the Chairman and Clerk be, and hereby are, authorized and directed to take such steps as are necessary to implement this resolution, including the execution of such agreement for and on behalf of the District.

The Clerk next reviewed the Agenda which had been available for public inspection in accordance with the law prior to this meeting of the Board of Trustees and reported that all matters considered by the Board at this meeting appeared on the Agenda.
