
This is to certify that Sanitary and Improvement District No. 264 of Sarpy County, Nebraska, levied special assessments upon lots and parcels of land as set out in the attached copy of the final Assessment Schedule for: (1) Sanitary Sewer, Paving & Water, Section II Storm Sewer, Section VI (Shadow Lake); and (2) Storm Sewer, Section V, Waterway #3 Improvements (Shadow Lake) (the "Improvements"); such Final Schedule being made a part hereof by this reference.

The special assessments were levied by the Board of Trustees for such District on April 9, 2015. The special assessments shall become due within fifty (50) days after April 9, 2015, or on the following date to-wit: May 29, 2015, and if not paid within that period, shall become delinquent in ten (10) annual installments. The first installment shall be due and delinquent the 9th day of April, 2016, and subsequent installments shall be due and delinquent on the same day and month of each year thereafter. The special assessments shall draw interest on a per annum basis until

delinquent at the greater of (i) the rate of interest accruing on construction fund warrants registered against the District sixty (60) days prior to the actual levy of special assessments; or (ii) the average rate of interest accruing on the construction fund warrants issued to pay for the improvements for which the special assessments are to be levied adjusted to the next greater one-half percent. Delinquent installments shall bear interest at the rate of two percent (2%) per annum above the rate set by the District on such installment before delinquency.

As a result of the foregoing, the special assessments shall draw interest at the rate of seven and one-half percent (7.5%) per annum until delinquent and nine and one-half percent (9.5%) per annum after delinquency and until fully paid. All special assessments may be paid within fifty (50) days after the date of levy without interest charge.
