

CERTIFICATE TO COUNTY CLERK

I, Dawn Buck, the duly elected, qualified and acting Clerk of the Board of Trustees of Sanitary and Improvement District No. 282 of Sarpy County, Nebraska, hereby certify that at the special hearing to adopt property tax request different than prior year tax request held by the Board of Trustees of said District on September 12, 2012, at which hearing a quorum was present, the following resolution was duly adopted by such Board of Trustees, to-wit:

WHEREAS, *Neb. Rev. Stat. 77-1601.02* provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Board of Trustees passes by a majority vote a resolution setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of Sanitary and Improvement District No. 282 of Sarpy County that the property tax request for the current year be a different amount than the property tax request for the prior year.


NOW, THEREFORE, the Board of Trustees of Sanitary and Improvement District No. 282 of Sarpy County, Nebraska, by a majority vote, resolves:

That the 2012-13 property tax request be set at \$89,526.92 for the General Fund and \$100,717.79 for the Bond Fund;

BE IT FURTHER RESOLVED, that a copy of this resolution be certified and forwarded to the County Clerk.
