WHEREAS, pursuant to Neb. Rev. Stat. §23-103(Reissue 1997), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, a the County Aid Enhancement grant (\$12,625 State Funds and \$5,050 Local Match) has been awarded to Sarpy County through the Nebraska Crime Commission after the adoption of the 2009 fiscal year budget.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the County Aid Enhancement fund is hereby created and appropriated in the amount of \$12,625 as shown in Exhibit A.




