NOW, THEREFORE, BE IT RESOLVED, by the Sarpy County Board of Commissioners that furniture/equipment from the Administration Remodel Project is hereby declared to be surplus property and the Purchasing Department is hereby authorized to dispose of the furniture/equipment in the best interest of Sarpy County.
