WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 1997), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 1997), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Sarpy County (hereinafter "County") and South Sarpy School District Number 46 and Sarpy County School District 37 (hereinafter "School Districts"), have entered into agreements dated August 1, 2006 for the purpose of providing a school resource deputy; and,

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the term of the agreements shall be for a period of three (3) years commencing on or about July 1, 2009 until June 30, 2012 with the cost of the program at 50% of average cost and all other terms remaining the same.

1. The term of this Agreement shall be extended for a period of three (3) years commencing on or about July 1, 2009 and ending on or about June 30, 2012
2. Cost of Program: The cost of the program shall be paid by School District as follows:


Period 1: July 1, 2009 through June 30, 2010	50% of average cost

Period 3: July 1, 2011 through June 30, 2012	50% of average cost







2. Cost of Program: The cost of the program shall be paid by School District as follows:





Re: Authorize Chairman to sign Addendum for School Resource Deputy

During the July 28, 2009 Board meeting, I will be asking the Chairman to sign the Addendums to Interlocal Cooperation Agreements to facilitate a "School Resource Officer" Program. The Program was previously approved by the Board on August 1, 2006 and seeks to ensure the safety and security of students.


The Sarpy County Sheriff's Department provides one (1) School Resource Deputy to serve in the public high schools, middle schools and elementary schools to assist the South Sarpy School District Number 46 and Sarpy County School District 37 (Gretna Public School District) in the education of students and faculty, assist in communication between the districts, County, and Sheriff's Department, and to take appropriate action when situations arise which require the exercise of police authority. The current interlocal agreements between the County and the two (2) school districts expired on June 30, 2009.

Under the terms of the Agreement the school districts reimburse Sarpy County for one half of the deputy costs. When school is not in session (e.g. summer breaks and holidays) or when needed in emergencies, the deputies perform Sarpy County functions.

This is a continuation of an existing agreement that has been in place for several years. The term of the new agreements shall be for a period of three (3) years ending on June 30, 2012.
