

**BOARD OF COUNTY COMMISSIONERS

RESOLUTION APPOINTING TEMPORARY ALTERNATE PUBLIC DEFENDER**

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Carl Kretsinger, the current appointed Alternate Public Defender for Child Support Orders has recently retired; and,

WHEREAS, it is necessary to appoint a Temporary Alternate Public Defender to perform the services for Child Support Orders; and,

WHEREAS, the District Judges have recommended Amy Melton to act as counsel for said services.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners that, in order to both control and determine expenditures for indigent defense and cases involving child support orders where the Public Defender is disqualified, the Sarpy County Board of Commissioners does hereby request and approve the appointment of Amy Melton to handle such matters on a temporary basis for a monthly fee, to include routine office expenses, of \$3,182.70 per month commencing on November 1, 2009. Said appointment to continue until such time as a permanent Alternate Public Defender is appointed or unless terminated by either party upon ninety (90) days notice to the other.


