
Re: Nebraska Office of Highway Safety Mini-Grant Application and Award for in-car cameras for the Sarpy County Sheriff's Office for the Sarpy County Traffic Unit

On October 20, 2009, the County Board will be asked to approve the submission of the attached mini-grant application and award for in-car cameras for the Sarpy County Sheriff's Office for the Sarpy County Traffic Unit.

The grant will provide funding for the Sarpy County Sheriff's Office (SCSO) to purchase 2 in-car cameras for use in SCSO cruisers in the Traffic Unit. The grant application requests \$7,000. The Nebraska Office of Highway Safety will reimburse Sarpy County up to \$3,500 per camera through this mini-grant. The total cost of each camera is \$5,615; therefore Sarpy County will be responsible for \$2,115 for each radar for a total cost of \$4,230.

- 2) a description of the equipment to be purchased, including make, model and manufacturer;
- 3) an itemized cost summary of the equipment to be purchased; and,
- 4) a copy of your agency's current seat belt policy and drug-free workplace policy.

- 1) An invoice from the applicant to NOHS. The invoice must itemize each expenditure.
- 2) Copy of the check(s) paid by the applicant for the equipment.
- 3) Copy of the invoice from the manufacturer which itemizes the cost of the equipment.

Within sixty (60) days from the date of this award the reimbursement request must be submitted to NOHS.

After sixty (60) days, reimbursements will not be honored. Acceptance of Conditions: The Mini-Grant Contract Award recipient agree to all applicable federal and state laws, rules and regulations.
