WHEREAS, the Census is also used to help determine where to locate schools, day care centers, senior citizen centers, hospitals, and other facilities and is used to make decisions concerning business growth and jobs; and

WHEREAS, the Census information is confidential and Federal law prohibits any public or private agency from gaining access to confidential Census data; and

WHEREAS, in Sarpy County, Nebraska, we are committed to a full and accurate Census count and are placing special emphasis on enumerating members of population groups traditionally undercounted; and


WHEREAS, in Sarpy County, Nebraska, we shall form a Census 2010 Complete Count Committee composed of key stakeholders within our communities, including elected officials, planners, community based organizations, business groups, religious institutions, and member of the media; and
