NOW, THEREFORE, BE IT RESOLVED, by the Sarpy County Board of Commissioners that roller shelving from Register of Deeds is hereby declared to be surplus property and the Purchasing Department is hereby authorized to dispose of the shelving in the best interest of Sarpy County.


