RESOLUTION INCREASING APPROPRIATIONS FOR THE 2010 FY BOAT PATROL BUDGET

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, additional appropriations are needed for the continued operation of the various funds listed below after the adoption of the 2010 fiscal year budget; and,

WHEREAS, Section 13-511 provides that the previously adopted budget may be supplemented after conducting a public hearing.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the following fund is hereby increased:

FG-Boat Patrol fund budget is hereby increased by \$5,621 from \$2,029 to \$7,650 due to the correction of available federal grant funds previously awarded. The source of revenue to cover the increase in budgeted expenditures will be federal funds.

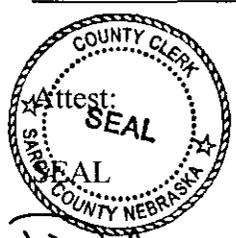

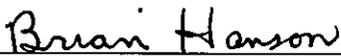
Re: Increasing Appropriations for the 2010 FY Budget

I have placed a public hearing on the March 16, 2010 Board agenda for the purpose increasing funds for two existing grant budgets. The attached Resolutions will authorize the increase of the following funds:

1. The FG-Drug Enforcement fund budget will be increased by \$74,506 because the final grant award amount was not available prior to the adoption of the 2010 FY budget. The source of funds will be federal funds.
