RESOLUTION CREATING AND APPROPRIATING FUNDS FOR FG-ARRA TITLE 1D
FUND

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6)(Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103(Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Section 13-511 provides that the previously adopted budget may be supplemented after conducting a public hearing.

WHEREAS, a Federal Stimulus grant was awarded through the Papillion LaVista School District to Sarpy County Juvenile Justice Center for the purchase of program supplies, data processing equipment and operating expenses after the adoption of the 2010 fiscal year budget.

WHEREAS, Federal Stimulus funds will be the source of revenue.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the FG-ARRA Title 1D fund is hereby created and appropriated in the amount of \$30,846 as shown in Exhibit A.






Re: Creating & Appropriating Funds for 2010 FY Budget

I have placed a public hearing on the March 16, 2010 Board agenda for the purpose of creating and appropriating funds for five new funds to be added to the 2010 FY budget. The attached Resolutions will authorize the creation and appropriate funds for the following funds:

- The FG-Homeland Security fund will be added in the amount of \$47,350 because a federal grant was awarded through the Nebraska Emergency Management Agency for the purchase of radios. The source of funds will be federal funds.
- The FG-ARRA Title 1D fund will be added in the amount of \$30,846 because a federal stimulus grant was awarded through the Papillion LaVista School District to the Sarpy County Juvenile Justice Center for the purchase of program supplies, data processing equipment and operating expenses. The source of funds will be federal funds.
- The Connection Fee fund will be added in the amount of \$55,000 for the collection of water connection fees for Tiburon. The source of funds will be water connection fees.
- The Stadium Bonds Public fund will be added in the amount of \$500,000 to be used for debt service payments on the baseball stadium. The source of funds will primarily be Keno and Visitor Improvement funds.
- The Stadium Bonds Private fund will be added in the amount of \$400,000 to be used for debt service payments on the baseball stadium. The source of funds will primarily be rent and other payments from the Omaha Royals.
