

PRIDE Omaha/Live Wise Coalition, MIP Underage party patrols Every year PRIDE Omaha and the Live Wise Coalition provide funding for MIP (Minor in possession of Alcohol) party patrols. We are requesting six (6) days of extra patrols with two (2) officers covering Homecoming events, Proms and High School Graduations. This grant is 100% funded by PRIDE, there is no local match required. This contract is also renewable every year. We have participated in this grant for several years. The total for this grant request is \$2,394.32 which covers two deputies for six (6) hours x 6 days of activity.

PRIDE Omaha, Tobacco Compliance Checks . PRIDE Omaha relies on the Sarpy County Sheriff to complete Tobacco Compliance checks. These funds are used at our discretion for compliance checks, checking retail vendors for the sale of tobacco products to minors. PRIDE has authorized \$3,400 thru June 30, 2011. The grant pays for all expenses, including mileage for these compliance checks in the Sarpy County area. There is no local match for this grant.
