

PROJECT DESCRIPTION: The purpose of this Mini-Grant Contract is to provide funding assistance to law enforcement agencies for selective overtime enforcement in the emphasis area of: (Check One) Alcohol [x], Speed, or General Traffic. Regular traffic enforcement activities must remain at the current level and all activities funded by this mini-grant must be above and beyond the current level of enforcement activity.


Re: Selective Alcohol Overtime Enforcement Mini-Grant Award for the National "You Drink and Drive, You Lose" campaign.
