WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, on November 9, 2010, Sarpy County approved an Agreement with Jaime Bonet for interpreter services for the Law Enforcement Center, and Jaime Bonet further determined that said agreement posed a conflict of interest; and,

WHEREAS, Jaime Bonet is agreeable to rescinding said Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS THAT the Agreement for Interpreter Services for the Law Enforcement Center with Jaime Bonet having been previously approved by this Board on November 9, 2010, is hereby rescinded.


