Re: 2011-2012 Juvenile Accountability Block Grant Application

On March 1, 2011 the County Board will be asked to give Lisa Haire permission to write the Juvenile Accountability Block Grant (JABG) application. This is a continuation grant that will allow Sarpy County to continue programs offered at the Juvenile Reporting Center, Juvenile Diversion Office, and Juvenile Drug Court. The grant application is due April 15, 2011.

The project period is July 1, 2011-June 30, 2012. The application will request \$19,077. \$11,345 will fund contracts for several programming options at the Juvenile Reporting Center. \$3,462 will be used to purchase supplies for programs offered at the Juvenile Reporting Center and Juvenile Diversion's Teen Court Program. \$3,096 will provide drug testing supplies for the Sarpy County Juvenile Intake Program, and \$1,174 will be used to fund pro-social events for juvenile participants in Drug Court.

The County is required to provide a 10% cash match of \$2,119. The match will include expenses involved in detaining Sarpy County youth who are inappropriate for detention at the Sarpy County Juvenile Justice Center. The Douglas County Youth Center will be used when necessary for detention. This contract will be funded with match dollars that will be taken from the Sarpy County General Fund.
