RESOLUTION APPROVING STREET NAMES FOR LITTLE PRAIRIE

WHEREAS, pursuant to Neb. Rev. Stat. § 23-104 (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, the Little Prairie Final Plat was approved on July 12, 2006, however, street names were not included at that time; and,

WHEREAS, Neb. Rev. Stat. §39-1402 (Reissue 1998) grants to the County Board authority for the improvement, maintenance and general supervision of public roads; and,

WHEREAS, Rebecca Horner, Planning Director has provided a report and recommendation regarding the proposed street names for Little Prairie, as noted in the attached Exhibit A, which Exhibit A includes the Planning Director report and a document showing the proposed street names for Little Prairie; and,

WHEREAS, the proposed street names for Little Prairie, have been reviewed and approved by the Sarpy County GIS department; and,

WHEREAS, adding street names as proposed herein would result in greater uniformity and be a benefit to the County.

NOW, THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners that this Board hereby approves the proposed street names for Little Prairie, and all pertinent records shall reflect said change.

- Summary of Request
