WHEREAS, the County Engineer has prepared his recommendation concerning said vacation; and,


WHEREAS, pursuant to Neb. Rev. Stat. §39-1722, *et seq.*, (Reissue 2008), the County Board of Commissioners is authorized to vacate or abandon certain roadways or parts thereof.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS that pursuant to Neb. Rev. Stat. §39-1722, *et seq.*, (Reissue 2008) a public hearing will be held on the 10th day of January, 2012 at 3:00 p.m. in the Board Room of the Sarpy County Courthouse, Papillion, Nebraska, to receive public comment regarding the vacation of the following:

A portion of the existing 72nd street right-of-way adjacent to Lot 6, West Cornhusker Plaza, within Sarpy County, NE.

BE IT FURTHER RESOLVED that the Clerk is directed to publish notice of said public hearing as required by law.


EXHIBIT "A"

The Northerly 105.43 feet of the Easterly 63.05 feet of 72nd Street Right-of-way going west and north of Lot 6, West Cornhusker Plaza a subdivision in said Sarpy County, Ne., and Southerly of 71st Plaza Right-of-way.
