RESOLUTION AMENDING INTERLOCAL COOPERATION AGREEMENT FOR ANIMAL CONTROL SERVICES WITH THE NEBRASKA HUMANE SOCIETY

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, The Nebraska Humane Society has previously entered into Interlocal Cooperation Agreement approved by the Sarpy County Board of Commissioners pursuant to the Interlocal Cooperation Act, Neb. Rev. Stat. §13-801 to 827 (Reissue 2007), by which the Nebraska Humane Society would provide animal control services within the County and said agreement is in the best interest of the citizens of Sarpy County; and,


WHEREAS, it is in the best interest of the citizens of Sarpy County to amend said Interlocal Cooperation Agreement by extending the term of said agreement through October 31, 2021.

NOW, THEREFORE BE IT RESOLVED, By the Sarpy County Board of Commissioners that the attached Addendum is approved and the Chairman of such Board is hereby authorized to sign the same.

The above resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 13th day of December, 2011.

ADDENDUM TO CONTRACT

THIS ADDENDUM is made by and between the County of Sarpy, of the State of Nebraska, a Body Politic and Corporate, hereinafter referred to as "County", and the Nebraska Humane Society, hereinafter referred to as "Vendor".

WHEREAS, the parties have previously entered into an Agreement for certain animal control services, which contract was entered into on August 22, 2000 and subsequently amended, and;

WHEREAS, it is in the best interest of Sarpy County to extend the term of said Agreement, and;

WHEREAS, County and Vendor desire to amend the terms of the previous Agreement.

NOW, THEREFORE, it is hereby agreed by and between the parties:

I. AMENDMENT

The prior contract between the parties, the same as signed by the County on August 22, 2000 and subsequently amended is hereby amended by the terms of this Addendum.

II.

The term of said Agreement is hereby extended for a period of ten (10) years effective November 1, 2011 through October 31, 2021.

III.

The Agreement may be terminated by either party for any reason by giving written notice as provided.

IV.

Population estimates shall be based solely on estimates prepared by the Census Bureau of the United States.

V.

The Vendor agrees to comply with the residency verification requirements of Neb. Rev. Stat. §4-108 through §4-114. Vendor is required and hereby agrees to use a federal immigration verification system to determine the work eligibility status of new employees physically performing services within the State of Nebraska. A federal immigration verification system means the electronic verification of the work authorization program authorized by the Illegal Immigration Reform and Immigrant Responsibility Act of 1996, 8 U.S.C. 1324a, known as the E-Verify Program, or an equivalent federal program designated by the United States Department of Homeland Security or other federal agency authorized to verify the work eligibility status of a newly hired employee.

VI.

The remaining terms and conditions of said prior Agreement shall remain unchanged.

Re: Animal Control Addendums

On December 13, 2011 the County Board will be asked to approve the attached addendums to the Interlocal Agreements with Bellevue, Springfield, Papillion, LaVista, Gretna and Ralston along with the Nebraska Humane Society for Animal Control Services.

The addendums will extend each agreement for ten (10) years, with the exception of Ralston, which will extend for five (5) years. The other major change addressed in the addendums is the language that determines population estimates. It has been agreed that the US Census will be used to make population determinations. The addendum also allows for the cities to submit alternative population figures with reliable supporting documentation provided to the County.
