WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, The Cities of Bellevue, LaVista, Papillion, Springfield and Gretna, Nebraska have previously entered into Interlocal Cooperation Agreement approved by the Sarpy County Board of Commissioners pursuant to the Interlocal Cooperation Act, Neb. Rev. Stat. §13-801 to 827 (Reissue 2007), by which Sarpy County would provide animal control services within the city limits of the aforementioned cities and said agreement is in the best interest of the citizens of Sarpy County; and,

WHEREAS, it is in the best interest of the citizens of Sarpy County to amend said Interlocal Cooperation Agreement by extending the term of said agreement through October 31, 2021

NOW, THEREFORE BE IT RESOLVED, By the Sarpy County Board of Commissioners that the attached Addendums are approved and the Chairman of such Board is hereby authorized to sign the same.

The above resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 13<sup>th</sup> day of December, 2011.

A federal immigration verification system means the electronic verification of the work authorization program authorized by the Illegal Immigration Reform and immigrant

Responsibility Act of 1996, 8 U.S.C. 1324a, known as the E-Verify Program, or an equivalent federal program designated by the United States Department of Homeland Security or other federal agency authorized to verify the work eligibility status of a newly hired employee.

VI The remaining terms and conditions of said prior Agreement shall remain unchanged.




