

**BOARD OF COUNTY COMMISSIONERS SARPY COUNTY, NEBRASKA**

**RESOLUTION APPROVING NAME CHANGE FOR A PORTION OF SOUTH 40TH STREET  
TO HARRISON TULL DRIVE**

WHEREAS, pursuant to Neb. Rev. Stat. § 23-104 (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Neb. Rev. Stat. §39-1402 (Reissue 2008) grants to the County Board authority for the improvement, maintenance and general supervision of public roads; and,

WHEREAS, a portion of South 40<sup>th</sup> Street from Capehart Road to a point approximately 1600 feet North of its intersection with Capehart Road is within the borders of Sarpy County, is with the extraterritorial jurisdiction of the City of Bellevue and is the access and egress to the Eastern Nebraska Veterans Home; and

WHEREAS, a name change request for that portion of South 40<sup>th</sup> Street has been received by the Sarpy County Engineer to change the name to "Harrison Tull Drive" in honor of Mr. Tull, a recently deceased resident of Sarpy County, civic leader, retired military officer and Tuskegee Airman ; and,

WHEREAS, Denny Wilson, Sarpy County Engineer, has provided a recommendation regarding the proposed street name change, as noted in the attached Exhibit A, which Exhibit A includes the County Engineer recommendation and a document showing the area of proposed street name change; and,

WHEREAS, the proposed street name change has been reviewed and approved by the City of Bellevue, as noted on Attachment B, and the Sarpy County GIS and 911 departments;


NOW, THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners that this Board hereby approves the proposed street name change for a portion of South 40<sup>th</sup> Street from Capehart Road to a point approximately 1600 feet North of its intersection with Capehart Road to "Harrison Tull Drive", and all pertinent records shall reflect said change.



# Memorandum

**To:** Sarpy County Board of Commissioners

**Re:** Renaming of a portion of 40<sup>th</sup> Street & Capehart Road to Harrison Tull Drive.

---

I recommend the name change of a portion of the roadway currently named 40<sup>th</sup> Street from Capehart Road to a point approximately 1600 ft. north of the intersection of 40<sup>th</sup> Street and Capehart Road. This intersection and street both lie within Bellevue's extra-territorial jurisdiction and will require concurrence from the Bellevue City Council before this name change can take effect.

The name of 40<sup>th</sup> Street would be changed to Harrison Tull Drive (or Street) in honor of the Tuskegee Airman of the same name. Mr. Tull served the United States Air Force during World War II and is recently deceased. This request is being made by Mr. Bob Rose in memory of Mr. Tull for his dedication and service to his country. The Eastern Nebraska Veteran's Home is located on this section of 40<sup>th</sup> Street which makes this dedication particularly appropriate. Extenuating circumstances also include the fact that 40<sup>th</sup> Street to the North is not currently a through street and will likely only be a collector street in the future.

I recommend to the Sarpy County Board of Commissioners that 40<sup>th</sup> Street be renamed to Harrison Tull Drive.
