ENFORCEMENT SUBGRANT- CLERK OF THE DISTRICT COURT



WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,



AMENDMENT ONE, JULY 2012


