

**BOARD OF COUNTY COMMISSIONERS
SARPY COUNTY, NEBRASKA
RESOLUTION AUTHORIZING TO CHANGE SPEED LIMIT ON CORNHUSKER ROAD**

WHEREAS, pursuant to Neb. Rev. Stat. 23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. 23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, a speed study has been conducted on Cornhusker Road from Fairby Drive to 192nd Street and from 192nd Street to 180th Street by the Sarpy County Public Works Department to change the speed limit from 50 miles per hour (mph) to 45 mph; and,

WHEREAS, the Sarpy County Public Works recommends to change the speed limit from 50 mph to 45 mph on Cornhusker Road from Fairby Drive to 192nd Street and from 192nd Street to 180th Street ; and,

WHEREAS, said speed limit change is in the best interests of the citizens of Sarpy County, Nebraska.

NOW THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners that the recommendation of the County Public Works to change the speed limit from 50 mph to 45 mph on Cornhusker Road from Fairby Drive to 192nd Street and from 192nd Street to 180th Street is hereby accepted, adopted, approved, ratified and confirmed.

BE IT FURTHER RESOLVED that Sarpy County shall take such steps to post appropriate signs according to the Manual on Uniform Traffic Control Devices at the locations as indicated on the location plan attached hereto as Exhibit "A".



SUBJECT: Resolution Authorizing to Change Speed Limit on Cornhusker Road

I recommend approval of the resolution to change the speed limit from 50 mph to 45 mph on Cornhusker Road from Fairby Drive to 192nd Street and from 192nd Street to 180th Street as shown on Exhibit "A" and described below:

- a) Sarpy County Public Works Department will be placing signs to make the public aware of the regulatory signs as per the Manual on Uniform Traffic Control Devices.
- b) Sarpy County Public Works Department will be notifying the Sarpy County Sheriffs Department of the change that will take place.

The Sarpy County Engineers office has reviewed the proposed speed reduction location. It is our recommendation that these signs are to be placed at the locations shown on the location plan.
