FOR JAIL COMMISSARY SERVICE

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Sarpy County (hereinafter "County") and DVAL Enterprises, Inc. (hereinafter "Vendor") have previously entered into an agreement on October 29, 2002 and amended November 7, 2006 for the provision of Jail Commissary Service; and,

WHEREAS, it is beneficial for both County and Vendor to extend the current Agreement for a period of two (2) years with two (2), two (2) year option periods.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the attached Addendum is hereby approved and the Chairman of such Board is hereby authorized to sign the same.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 21st day of August, 2012.




