WHEREAS, the grant application was submitted by the Sarpy County Sheriff's Office; and


WHEREAS, Sarpy County was awarded funding for overtime reimbursement to conduct the DUI Checkpoint; and,

WHEREAS, Sarpy County is committed to and supports funding for the grant referenced in the attached memo; and;




The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 28th day of August 2012.

On August 28, 2012, the County Board will be asked to ratify the submission and award for the Selective Overtime Enforcement mini-grant with the Nebraska Office of Highway Safety (NOHS) and the Sarpy County Sheriff's Office (SCSO). The grant was applied for and submitted by the SCSO.

The grant awards up to \$1,524.22 in overtime reimbursement to the SCSO to conduct a DUI Checkpoint in conjunction with the LaVista Police Department on September 1, 2012. The Sarpy County Sheriff's Office will aggressively pursue drivers who are impaired. The objective will be to ensure that impaired drivers are taken off Sarpy County roadways.



PROJECT DESCRIPTION: The purpose of this Mini-Grant Contract is to provide funding assistance to law enforcement agencies for selective overtime enforcement in the emphasis area of: (Check One) Alcohol , Speed , or General Traffic . The funding assistance will provide reimbursement for overtime salaries and/or mileage. Regular traffic enforcement activities must remain at the current level and all activities funded by this mini-grant must be above and beyond the current level of enforcement activity.

Participate in a DUI enforcement checkpoint with the La Vista Police Department and other area Law Enforcement agencies on Saturday September 1, 2012.

1. Baseline Information

The Sarpy County Sheriff's Office is applying for a "Selective Overtime Enforcement Mini-Grant" for the August 17 – September 3, 2012 "You Drink & Drive, You Lose" Crackdown. The Sarpy County Sheriff's Office would like to participate in this crackdown as. During this holiday time, our community has experienced several serious and fatal motor vehicle accidents in previous years. These serious and fatal motor vehicle accidents have occurred both during the daytime, as well as night, and have mainly occurred on the major roadways in Sarpy County. Unfortunately, many of the serious motor vehicle accidents involved intoxicated drivers.

2. Selective Overtime Enforcement Objective

The Sarpy County Sheriff's Office believes that with the assistance from your office, we can put more deputies on the roadways during this holiday season and significantly reduce the number of serious and fatal motor vehicle accidents, by targeting speeders, traffic violators, and most importantly, intoxicated drivers. By targeting the roadways and traffic violation, the Sarpy County Sheriff's Office believes we can significantly reduce the number of serious motor vehicle accidents in Sarpy County Nebraska.

4. Selective Overtime Budget

The Sarpy County Sheriff's Office would like to provide four (4) deputies for six (6) hours for this DUI checkpoint. We would also like to provide one (1) Booking Clerk for six (6) hours for this enforcement activity. The following overtime costs would be as follows:

Four (4) Deputies overtime for six (6) hours = \$1,115.50 + Social Security \$83.34 + Retirement \$97.61 = \$1298.45

One (1) booking Clerk overtime for six (6) hours = \$197.35 + Social Security \$15.10 + Retirement \$13.32 = \$225.77

Total = \$1,524.22

5. Impact Evaluation

Through the use of this "Selective Overtime Enforcement Mini-Grant", the Sarpy County Sheriff's Office is expecting to reduce the number of alcohol/drug related impaired driver's that operate on the roadways of Sarpy County on the night of Saturday September 1, 2012. As always, our goal is to reduce the number of accidents that impaired driver's cause on our roadways.
