

**BOARD OF COUNTY COMMISSIONERS
SARPY COUNTY, NEBRASKA
RESOLUTION AUTHORIZING A STOP SIGN ON SACK ROAD AT 192nd STREET**

WHEREAS, pursuant to Neb. Rev. Stat. 23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. 23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 39-1402 (Reissue 2008), general supervision and control of the public roads of each county is vested in the county board.

WHEREAS, a location plan has been created by the Sarpy County Public Works Department for the placement of a "STOP" sign on Sack Road at the intersection of 192nd Street as indicated on the location plan; and,

WHEREAS, the Engineer recommends that a "STOP" sign be placed on Sack Road at the intersection of 192nd Street as indicated on the location plan attached hereto as Exhibit A; and,

WHEREAS, placing the signs as indicated is in the best interests of the citizens of Sarpy County, Nebraska.

NOW THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners that the recommendation of the County Engineer for placement of a "STOP" sign on Sack Road at the intersection of 192nd Street as indicated on the location plan is hereby accepted and approved.

BE IT FURTHER RESOLVED that Sarpy County shall take such steps to post appropriate signs according to the Manual on Uniform Traffic Control Devices at the locations as indicated on the location plan attached hereto as Exhibit A.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with the applicable law on the 25th day of September, 2012.

SUBJECT: Resolution Authorizing a Stop Sign on Sack Road at 192nd Street
