**RESOLUTION APPOINTING TOM ACKLEY TO THE
SARPY COUNTY PLANNING COMMISSION**

WHEREAS, pursuant to Neb. Rev. Stat. §23-114 (Reissue 2007), the County Board of Commissioners has the power to create a Planning Commission; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-114.01 (Reissue 2007), the members of said Planning Commission are appointed by the County Board of Commissioners; and,

WHEREAS, Planning Commission Member John Thompson's term will expire on December 31, 2012, and County Commissioner Rusty Hike has made a recommendation that Tom Ackley be appointed to the Planning Commission as John Thompson's replacement.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS THAT Tom Ackley is hereby appointed to the Sarpy County Planning Commission, said term beginning on January 1, 2013 for a three year term which shall expire on December 31, 2015.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 11th day of December, 2012.

There are seven (7) members of the Sarpy County Planning Commission whose terms expire on December 31, 2012. Resolutions have been prepared for the appointment of two new members and the reappointment of five current members as recommended by the County Commissioners.

State Statutes require that approximately only one-third of the positions on a Planning Commission be up for appointment at one time. This allows for staggered terms which provide continuity and history for the Commission to draw upon. We are not sure how our existing member's terms got out of sync in recent years but in order to get them back in line and meet statute requirements, I am recommending terms of one, two and three years for various members being appointed or reappointed as shown below. The length of the term for each member was randomly selected. Members may continue to be reappointed at the end of their specific term if it is the County Commission's recommendation at that time. With this adjustment, the Planning Commission will be back to having three positions up for appointment at the end of 2013, four members up for appointment at the end of 2014, and four members up for appointment at the end of 2015. The list below indicates the current and proposed term dates for each member.
