

**BOARD OF COUNTY COMMISSIONERS

RESOLUTION AUTHORIZING REGULATORY SIGNS ALONG 168th STREET**

WHEREAS, pursuant to Neb. Rev.Stat. 23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. 23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 39-1402 (Reissue 2008), general supervision and control of the public roads of each county is vested in the county board.

WHEREAS, a location plan has been created by the Sarpy County Public Works Department for the placement of "CENTER LANE LEFT TURN ONLY" and "DO NOT BLOCK INTERSECTION" signs along the west side of 168th Street from south of Ridgemont Street to north of Oakmont Drive as indicated on the location plan; and,


WHEREAS, the Surveyor/Engineer recommends that "CENTER LANE LEFT TURN ONLY" and "DO NOT BLOCK INTERSECTION" signs be placed along the west side of 168th Street from south of Ridgemont Street to north of Oakmont Drive as indicated on the location plan attached hereto as Exhibit A; and,

WHEREAS, placing the signs as indicated is in the best interests of the citizens of Sarpy County, Nebraska.

NOW THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners that the recommendation of the County Surveyor/Engineer for placement of "CENTER LANE LEFT TURN ONLY" and "DO NOT BLOCK INTERSECTION" signs along the west side of 168th Street from south of Ridgemont Street to north of Oakmont Drive as indicated on the location plan is hereby accepted and approved.

BE IT FURTHER RESOLVED that Sarpy County shall take such steps to post appropriate signs according to the Manual on Uniform Traffic Control Devices at the locations as indicated on the location plan attached hereto as Exhibit A.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with the applicable law on the 28th day of February, 2012.



SUBJECT: Resolution Authorizing Regulatory Signs along 168th Street

I recommend approval of the resolution to place "CENTER LANE LEFT TURN ONLY" and "DO NOT BLOCK INTERSECTION" signs along the west side of 168th Street from south of Ridgemont Street to north of Oakmont Drive as described below:

a) Sarpy County Public Works Department will be placing signs to make the public aware of the regulatory signs as per the Manual on Uniform Traffic Control Devices.

b) Sarpy County Public Works Department will be notifying the Sarpy County Sheriffs Department of the change that will take place.

The Sarpy County Engineers office has reviewed the proposed location of the signs in question. It is our recommendation that these signs are to be placed at the locations shown on the location plan.
