RESOLUTION TERMINATING CONTRACT WITH TREAT AMERICA FOOD SERVICES

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the county necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,


WHEREAS, on May 6, 2008, this Board entered into a contract with Treat America Food Services for vending services at various county locations, a copy of which is attached hereto as Exhibit A; and,

WHEREAS, according to its terms, said contract has automatically renewed on an annual basis since May 6, 2009 and Treat America Food Services has continued to provide vending services to the County pursuant to the terms of the contract; and,

WHEREAS, pursuant to the third paragraph of section four of the contract, the County wishes to terminate said contract by giving Treat America Food Services sixty (60) days prior written notice of such termination.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS that Sarpy County shall terminate the aforementioned contract according to its terms and that the Sarpy County Senior Buyer/Contract Administrator and/or Purchasing Agent shall take such actions as may be necessary to terminate said contract.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 28th day of February, 2012.



Re: County Vending Services

On May 6, 2008 the County Board authorized a contract with Treat America for vending services. Per the agreement, either party may terminate the contract with sixty (60) days written notice to the other party. The Purchasing Department is requesting the Board to approve the attached Resolution that will terminate the agreement with Treat America effective April 30, 2012.

The County continues to have concerns with the level of service presented by Treat America in both the delivery and quality of products. Therefore, quotes were solicited from several area vending companies. Two companies responded with proposals. Upon approval of the attached resolution, the Purchasing Department will begin coordinating a new agreement and transition plan with a newly selected vendor.
