WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6)(Reissue 1997), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103(Reissue 1997), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, the Nebraska Department of Revenue requires Sarpy County to submit a Form 50G for the renewal of Sarpy County's Keno license; and,

WHEREAS, the Nebraska Department of Revenue requires Sarpy County to submit a Form 50G-I for the renewal of the Lottery Operator License; and,

WHEREAS, Advanced Gaming Technologies, Inc. is the current Lottery Operator for Sarpy County; and,

WHEREAS, the Nebraska Department of Revenue requires Sarpy County to submit Form 50G-II for the renewal and non-renewal of Lottery Sales Outlet licenses for lottery outlets in Sarpy County; and,

WHEREAS, M Martian LLC (On the Rocks Lounge), LaPlatte Enterprises, Inc. (Lodge), High Spirits, Inc. (Waterfall Lounge), Catfish Lake and Depot, Inc. (Rum Runner) operate keno lottery outlets in Sarpy County; and,

WHEREAS, Paso Holdings LLC (Rodeway Inn) and GAM Enterprises LLC (American Bistro) are no longer keno lottery outlets in Sarpy County.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the Chairman of such Board is hereby authorized to sign the following attached forms

1. Form 50G County/City Lottery Sales Outlet Location Application to renew Sarpy County's Keno License.
2. Form 50G-I County/City Lottery Operator Application to renew Advanced Gaming Technologies, Inc. Lottery Operator license.

3. Form 50G-II County/City Lottery Sales Outlet Applications to renew Sarpy County Keno outlet licenses for M Martian LLC (On the Rocks Lounge), LaPlatte Enterprises, Inc. (Lodge), High Spirits, Inc. (Waterfall Lounge), Catfish Lake and Depot, Inc. (Rum Runner) .
4. Form 50G-II County/City Lottery Sales Outlet Application not to renew Paso Holdings LLC (Rodeway Inn) and GAM Enterprises LLC (Americana Bistro), .

### **NOTICE TO COUNTY/CITY LOTTERY LICENSEES ONLINE FILING OF COUNTY/CITY, LOTTERY OPERATOR, AND SALES OUTLET LICENSE APPLICATIONS**

Enclosed are your 2012-2014 county/city lottery renewal applications. The Charitable Gaming Division of the Nebraska Department of Revenue (Department) has made available the ability for a community to renew their county/city lottery licenses online and pay the license fee electronically. One of the Department's goals is to reduce paper, and this new online capability will help us continue our efforts to achieve that goal. Of course, you still have the option of filing a paper copy of your renewal applications with our office as you have done in the past.

#### **ONLINE RENEWAL AND ELECTRONIC PAYMENT**

After you have accessed the Charitable Gaming website, select Online Services. From the License Information and Online Processes screen, click on County/City Lottery in the column entitled License Renewals. The login screen will require you to enter the Nebraska Identification Number (35-XXXXXXX) of your community and your assigned PIN.

#### **ONLINE AUTHORIZATION OF LOTTERY OPERATORS AND SALES OUTLETS BY GOVERNING OFFICIAL**

Lottery operators and sales outlets have received their own set of instructions for completion of their online renewals. Once they have completed the process, the community is required to approve the application for submission to the Department. In order to approve the application, a governing official must access the License Information and Online Processes screen by following the instructions stated above. Depending on which type of license you are approving, click on either Lottery Operator or Sales Outlet Location in the column entitled License Renewals.

- Enter the Nebraska Identification Number of the county, city, or village and the PIN indicated above and Click Submit.

- The License Information Screen displays and identifies any pending license renewal applications which require an authorization. You may select all of them and only sign for them one time. Follow the instructions on the screen.
- The Signature Page is displayed and identifies the name of each governing official who may approve the applications for submission to the Department. Check the applicable box and select Next.

#### **FILE UPDATED INFORMATION**

Although you are not required to resubmit any information that was included with your original license application or prior license renewals, you are required to keep current all information on file regarding your lottery. If you have not previously filed this information, please provide copies of any new lottery operator agreement, amendments to your existing lottery operator agreement, or authorized extensions to the agreement, any new ordinances or resolutions which have been adopted relative to your lottery, any changes to pay tables or rules of play, and any other official documents relating to your lottery.

#### **DUE DATE**

If you renew your license online, the application and the \$100 license fee must be filed by April 1, 2012. If you complete the paper application, mail the application and \$100 license fee to the Nebraska Department of Revenue, Charitable Gaming Division, P.O. Box 94855, Lincoln, NE 68509-4855, no later than April 1, 2012.

Any county, city, village, lottery operator, or sales outlet location which does not hold a 2012-2014 license required by Nebraska law on June 1, 2012, must cease county/city lottery activity until the applicable license is physically present to allow legal operation of the game. An administrative fine may be imposed on all applicants not filing their license renewal applications on time.
