**RESOLUTION APPROVING ADDENDUM TO AGREEMENT WITH ALEGENT HEALTH FOR JUVENILE SERVICES**

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, an agreement was approved on January 10, 2012 by which Alegent Health will provide certain care, treatment, evaluation, safekeeping and assessment of juveniles under the control of the Sarpy County Juvenile Court; and,

WHEREAS, Alegent Health has the expertise and ability to provide such services; and,

WHEREAS, the agreement is extended for a one (1) year term commencing on January 1, 2013 through December 31, 2013.


NOW, THEREFORE, BE IT RESOLVED BY THIS BOARD OF COUNTY COMMISSIONERS that the Amendment to the Agreement with Alegent Health for the care, treatment, evaluation, safekeeping and assessment of Juveniles under the control of the Sarpy County Juvenile Court, a copy of which is attached hereto, is hereby approved, and the Chair and the Clerk are authorized to sign the same.

**AMENDMENT**

THIS AMENDMENT is entered into by and between the County of Sarpy, Nebraska, a political subdivision of the State of Nebraska, hereinafter referred to as "Sarpy County", and Alegent Creighton Health f/k/a Alegent Health, hereinafter referred to as "Alegent".

WHEREAS, the parties entered into an Agreement executed by Sarpy County on January 10, 2012, attached hereto and incorporated by this reference, for the care treatment, evaluation, safekeeping and assessment of juveniles under the control of the Sarpy County Juvenile Court by Alegent; and

WHEREAS, the original term of the Agreement is from January 1, 2012 to December 31, 2012 and has the option to renew for one (1) year periods upon expressed written consent of both parties; and

WHEREAS, the parties wish to renew the agreement for an additional one (1) year term beginning January 1, 2013 and ending December 31, 2013.

NOW, THEREFORE, in consideration of the mutual covenants contained in the attached Agreement and stated herein the parties agree as follows:

1. The Agreement shall be renewed for an additional one (1) year term beginning January 1, 2013 and ending December 31, 2013.
2. All other terms of the Agreement, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
