Outlot 1, 370 Pointe, a subdivision as surveyed, platted and recorded ins Sarpy County, Nebraska,




WHEREAS, it is the judgment of this Board that it is the judgment of this Board that the above described property be acquired for the use in the Marv Holubar Trail Project.
