

**BOARD OF COUNTY COMMISSIONERS  
SARPY COUNTY, NEBRASKA  
RESOLUTION AUTHORIZING "NO PARKING" SIGNS WITHIN S.I.D. #233**

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, pursuant to Neb. Rev. Stat. §39-1816 (Reissue 2008), the County Board may prohibit or restrict parking of motor vehicles on the right-of-way of county roads and may erect signs giving notice of no parking or restricted parking; and,

WHEREAS, pursuant to Neb. Rev. Stat. Sect. 60-680 (Reissue 2010), the County Board may regulate stopping, standing or parking with respect to roads under its jurisdiction; and,

WHEREAS, a location plan has been submitted to the Sarpy County Public Works Department for the placement of "NO PARKING" Signs along Cottonwood Street, according to the location plan, within S.I.D #233, a copy of which is attached hereto as Exhibit A; and,

WHEREAS, the Surveyor/Engineer recommends that "NO PARKING" Signs along Cottonwood Street within S.I.D #233 according to the location plan, which such is in the best interests of the citizens of Sarpy County, Nebraska; and,

NOW THEREFORE, BE IT RESOLVED by the Sarpy County Board of Commissioners the recommendation of the County Surveyor/Engineer for placing of the "NO PARKING" Signs along Cottonwood Street within S.I.D #233 in accordance with the location plan, is hereby accepted and approved

BE IT FURTHER RESOLVED that S.I.D #233 shall take such steps to post appropriate signs according to the Manual on Uniform Traffic Control Devices at the locations as indicated on the location plan attached hereto as Exhibit A.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with the applicable law on the 22<sup>nd</sup> day of April, 2014.





\* NO PARKING SIGNS TO BE


