
WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board;

WHEREAS, the plotter and copier/printer, as listed below, has been determined to be obsolete or not usable by the County.


- HP Plotter 1055 CM Design Jet SG2CT1310K - Sarpy ID #002916


Please find below the description of HP Plotter and KIP copier/printer that Sarpy County Public Works is requesting permission to surplus.
