**RESOLUTION REAPPOINTING DOUG HILL TO
THE SARPY COUNTY BOARD OF ADJUSTMENT**

WHEREAS, pursuant to Neb. Rev. Stat. §23-168.01 (Reissue 2012), the County Board shall appoint a Board of Adjustment consisting of five members plus one alternate member, and said members shall serve terms of three years, and,

WHEREAS, the term of the Board of Adjustment Member Doug Hill expired on December 31, 2012; and,

WHEREAS, Commissioner Don Kelly has made a recommendation to the County Board that Doug Hill be reappointed to an additional term.

NOW THEREFORE BE IT RESOLVED by the Sarpy County Board of Commissioners that Doug Hill is hereby reappointed as a regular member of the Board of Adjustment, commencing on January 1, 2014 for a three year term which shall expire on December 31, 2016.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 14th day of January, 2014.
