RESOLUTION ADOPTING THE MASTER FEE SCHEDULE EFFECTIVE JULY 1, 2014

WHEREAS, pursuant to Neb. Rev. Stat. § 23-104 (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers;

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board of Commissioners;

WHEREAS, Neb. Rev. Stat. § 23-114.04 (Reissue 2012) authorizes the County Board of Commissioners to establish a fee schedule relating to the issuance of permits prior to the erection, construction, reconstruction, alteration, repair, or conversion of any nonfarm building or structure;

WHEREAS, Sarpy County owns and operates sanitary sewers located with the County and charges and collects certain fees for construction, acquisition, retirement of debt, maintenance and other costs related to said sanitary sewers; and,

WHEREAS, a Resolution establishing Sub Basin Regulations and Fee Schedule effective July 1, 2014 was approved at 2014-255; and,

WHEREAS, the Sub Basin Regulations and Fee Schedule should be referenced within the Master Fee Schedule as discussed in the Planning Department Report (Exhibit A); and,

WHEREAS, adoption of the proposed amendments to the Master Fee Schedule as set out in the attached documents is in the best interest of the general welfare of the citizens of Sarpy County.





SEWER CONNECTION FEE REGULATIONS

AUGUST 6, 2013

The attached fee schedule shall apply for the issuance of a permit to connect to the Sarpy County Interceptor Sewer, subject to the following rules of interpretations.

1. A structure or parcel of property acquires the right to connect to the Sarpy County Interceptor Sewer upon payment of the applicable fee, and the signing and approval of applicable agreements with the appropriate governmental entities. This right is subject to any specific conditions of the permit for such connection. The right to connect runs with the realty and/or the structure for which the permit is issued and fee paid. Fees may be due prior to the filing of the final plat, prior to issuance of the building permit, prior to physically connecting to the sewer, or any combination of these three events, as detailed in the attached schedules.
2. An additional fee shall be required for the expansion of existing facilities requiring a building permit for commercial, industrial and institutional properties if the expansion will take place outside the area that the original building permit connection fees were paid for, even if additional sewer connection is not required.
3. For existing development with existing structures, fees are payable only for actual connection with the Sarpy County Interceptor Sewer.
4. All payments shall be made through the Planning and Building Department of Sarpy County. The fees shall then be remitted either to Sarpy County or the appropriate governmental entity pursuant to any applicable interlocal agreements.
5. Commercial, industrial and institutional fees are paid on a per acre basis for the entire parcel. If applicant does not desire to pay a sewer fee on the entire parcel, said area may be replatted into smaller parcels, if done in a manner which complies with the then existing and applicable zoning and subdivision regulations. For parcels that are not platted, the entire sewer connection fee shall be due at the time of issuance of the permit.
6. Physical connection to the Sarpy County Interceptor Sewer, or to any sewer line that drains into the Sarpy County Interceptor Sewer, will not be allowed until: 1) the payment of any fees due to Sarpy County and/or any other governmental entity have been paid, and; 2) any and all required connection agreements have been signed by all parties. The required connection agreements may include waste water sewer agreements with Sarpy County, the

City of Omaha, and other applicable governmental entities. Any connection that violates this provision shall be subject to a penalty of 10% of the applicable fee, and will be disconnected until brought into compliance.

7. Connection to the Sarpy County Interceptor Sewer obligates the connecting party to pay ongoing flow charges for the treatment of the sewage entering the sewer, and for the ongoing maintenance of the Sarpy County Interceptor Sewer. Failure to pay flow charges on a timely basis shall subject the offending party to disconnection, as well as any other lawful remedies necessary to recover past due charges.

RESOLUTION APPROVING THE SUB BASIN REGULATIONS AND FEE SCHEDULE

WHEREAS, pursuant to Neb. Rev. Stat. § 23-104 (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Sarpy County owns and operates sanitary sewers located within the County and charges and collects certain connection fees for construction, acquisition, retirement of debt, and other costs related to said sanitary sewers; and,

WHEREAS, pursuant to Resolution 2014-~~253~~²⁵⁴, the County Board approved a First Amendment to the Sarpy County – Gretna Interlocal Cooperation Agreement which allows Sarpy County to collect and keep a fee for any outfall sewer owned by Sarpy County which connects to the Gretna Municipal Sewer; and,

WHEREAS, the proposed Sub Basin Regulations and Fee Schedule, attached hereto, establish the Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin areas and associated Sub Basin Fees due at the time of building permit application; and,

WHEREAS, Sarpy County approved two subdivision agreements found at Resolutions 2011-096 and 2011-352 which called for Sarpy County to expend approximately \$337,818.31 to provide sewer outfall service to the areas of the Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin. The amounts spent for said outfall service were above and beyond the usual expenditures of Sarpy County and not accounted for in the existing sewer connection fee schedule; and,


WHEREAS, said Sub Basin Fee will recoup the cost of the construction of the outfall sewers serving the Whitetail and Sunridge Drainage Sub Basins.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS that this Board after due deliberation and consideration, adopts the proposed Sub Basin Regulations and Fee Schedule, as attached hereto, and that the same have full force and effect of law, the effective date of the aforementioned Sub Basin Regulations and Fee Schedule shall be July 1, 2014.



 Sub Basin Fee Regulations and Fee Schedule
 June 26, 2014

The following fee schedule and regulations shall apply to the Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin.

1. The Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin are outlined on the drainage maps attached hereto.
2. All structures requiring a building permit on or after July 1, 2014 and located within the Whitetail Drainage Sub Basin or the Sunridge Drainage Sub Basin shall be required to pay a Sub Basin Fee. The Sub Basin Fee shall be in addition to all other fees applicable to the lot or structure.
3. The Sub Basin Fee shall be due at the time of the building permit application, payable to Sarpy County Planning and Building Department.
4. A building permit for structures within the Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin shall not be issued unless and until the Sub Basin Fee is paid.
5. Residential Sub Basin Fees are calculated per living unit.
6. Commercial, industrial, and institutional Sub Basin Fees are calculated on a per acre basis for the entire parcel.
7. The Sub Basin Fees are as follows:

	Sub Basin Fee due at building permit application
Residential: Single, duplex (per living unit), Mobile Home	\$400 per living unit
All other residential (per living unit)	\$250 per living unit
Commercial, Industrial (per acre)	\$1,600 per acre





RESOLUTION ESTABLISHING SEWER FLOW CHARGES

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Sarpy County owns and maintains a system of sanitary sewers in the north-central part of Sarpy County; and,

WHEREAS, a Resolution establishing sewer flow charges was adopted by the Sarpy County Board on September 7, 2004 to provide funds for the maintenance of the sanitary sewers; and,

WHEREAS, it is necessary and advisable to update the sewer flow charges:

1. To keep pace with rate increases being passed on to Sarpy County by the City of Omaha; and,
2. To accumulate funds required for on-going upkeep of the County's sanitary sewer system.

NOW, THEREFORE, BE IT RESOLVED: By the Sarpy County Board of Commissioners that the sewer flow charges set forth on the attached Exhibit A be and hereby are adopted and will be effective as of September 1, 2011.

SEWER CONNECTION FEE REGULATIONS

AUGUST 6, 2013

The attached fee schedule shall apply for the issuance of a permit to connect to the Sarpy County Interceptor Sewer, subject to the following rules of interpretations.

1. A structure or parcel of property acquires the right to connect to the Sarpy County Interceptor Sewer upon payment of the applicable fee, and the signing and approval of applicable agreements with the appropriate governmental entities. This right is subject to any specific conditions of the permit for such connection. The right to connect runs with the realty and/or the structure for which the permit is issued and fee paid. Fees may be due prior to the filing of the final plat, prior to issuance of the building permit, prior to physically connecting to the sewer, or any combination of these three events, as detailed in the attached schedules.
2. An additional fee shall be required for the expansion of existing facilities requiring a building permit for commercial, industrial and institutional properties if the expansion will take place outside the area that the original building permit connection fees were paid for, even if additional sewer connection is not required.
3. For existing development with existing structures, fees are payable only for actual connection with the Sarpy County Interceptor Sewer.
4. All payments shall be made through the Planning and Building Department of Sarpy County. The fees shall then be remitted either to Sarpy County or the appropriate governmental entity pursuant to any applicable interlocal agreements.
5. Commercial, industrial and institutional fees are paid on a per acre basis for the entire parcel. If applicant does not desire to pay a sewer fee on the entire parcel, said area may be replatted into smaller parcels, if done in a manner which complies with the then existing and applicable zoning and subdivision regulations. For parcels that are not platted, the entire sewer connection fee shall be due at the time of issuance of the permit.
6. Physical connection to the Sarpy County Interceptor Sewer, or to any sewer line that drains into the Sarpy County Interceptor Sewer, will not be allowed until: 1) the payment of any fees due to Sarpy County and/or any other governmental entity have been paid, and; 2) any and all required connection agreements have been signed by all parties. The required connection agreements may include waste water sewer agreements with Sarpy County, the

City of Omaha, and other applicable governmental entities. Any connection that violates this provision shall be subject to a penalty of 10% of the applicable fee, and will be disconnected until brought into compliance.

7. Connection to the Sarpy County Interceptor Sewer obligates the connecting party to pay ongoing flow charges for the treatment of the sewage entering the sewer, and for the ongoing maintenance of the Sarpy County Interceptor Sewer. Failure to pay flow charges on a timely basis shall subject the offending party to disconnection, as well as any other lawful remedies necessary to recover past due charges.

1. The Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin are outlined on the drainage maps attached hereto.
2. All structures requiring a building permit on or after July 1, 2014 and located within the Whitetail Drainage Sub Basin or the Sunridge Drainage Sub Basin shall be required to pay a Sub Basin Fee. The Sub Basin Fee shall be in addition to all other fees applicable to the lot or structure.
3. The Sub Basin Fee shall be due at the time of the building permit application, payable to Sarpy County Planning and Building Department.
4. A building permit for structures within the Whitetail Drainage Sub Basin and the Sunridge Drainage Sub Basin shall not be issued unless and until the Sub Basin Fee is paid.
5. Residential Sub Basin Fees are calculated per living unit.
6. Commercial, industrial, and institutional Sub Basin Fees are calculated on a per acre basis for the entire parcel.
