

Sarpy County Public Works has reviewed the plans for Sanitary Sewer – Section 2 (Pebblebrooke Lift Station Renovation), Phase 2 development for Sanitary and Improvement District No. 278 (SID 278), Tiburon Ridge, of Sarpy County. Our review indicates that the design, if followed, will meet the minimum standard requirements as specified in the 2003 3rd Edition of the City of Omaha Standard Specifications for Public Works Construction, which is acceptable to the Sarpy County Public Works Department.
