WHEREAS, pursuant to Neb. Rev. Stat. § 23-104 (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers;

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board of Commissioners;

WHEREAS, pursuant to Neb. Rev. Stat. § 23-813 (Reissue 2012), Werner Cycle Works ("Applicant") is required to obtain a license prior to conducting or operating a public amusement;

WHEREAS, the Applicant applied for an Amusement License, in accordance with Neb. Rev. Stat. § 23-813 *et seq.* and Resolution 2014-112 (describing the County's process for applying for and obtaining an Amusement License); and

WHEREAS, because the Applicant has complied with Neb. Rev. Stat. § 23-813 *et seq.* and Resolution 2014-112, the County desires to provide the Applicant with an Amusement License so it may conduct or operate the Werner Cycle Works 6th Annual Bike and Car Show on August 23rd.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS THAT the attached Application for an Amusement License is hereby approved.

BE IT FURTHER RESOLVED the above-referenced Amusement License is valid only for the event, date, and times listed in the attached application.






