RESOLUTION AWARDING BID FOR FINANCING FOR TWO (2) NEW TANDEM AXLE CAB CHASSIS, TWO (2) FOURTEEN FOOT (14') DUMP BODIES WITH HYDRAULIC SYSTEMS, TWO (2) STAINLESS STEEL MATERIAL SPREADERS, TWO (2) TWELVE FOOT (12') SNOW PLOWS AND ONE (1) NEW SINGLE AXLE CAB CHASSIS WITH SERVICE BODY, FRAME MOUNTED POST PULLER AND HIREACH AERIAL WORK PLATFORM FOR THE PUBLIC WORKS DEPARTMENT

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, bids for financing for various Public Works Equipment have been solicited, made, opened and reviewed pursuant to applicable Nebraska State Statutes; and,

WHEREAS, based on those proceedings, and after a public hearing, this Board has duly deliberated and considered the bids received; and,

WHEREAS, this Board desires to proceed forthwith in order to expedite and facilitate service to the citizens of Sarpy County.

NOW, THEREFORE, be it resolved by this Board of County Commissioners that:

- (1) The low bid of American National Bank for the Financing for Two (2) New Tandem Axle Cab Chassis, Two (2) Fourteen Foot (14') Dump Bodies with Hydraulic Systems, Two (2) Stainless Steel Material Spreaders, Two (2) Twelve Foot (12') Snow Plows and One (1) New Single Axle Cab Chassis with Service Body, Frame Mounted Post Puller and HiReach Aerial Work Platform for an Interest Rate - 1.41% and estimated monthly payments of \$17,145.70 is accepted, ratified, and confirmed.
- (2) This Board's Chairman, Clerk, and Attorney are hereby authorized and directed to execute such ancillary documents as may be required to evidence the contract and take any and all steps necessary or required in order to carry out the terms of such contract after said documents have been reviewed by the Attorney, Fiscal Administrator, and County Administrator.

The above resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 20th day of

August, 2014.

Sarpy County is soliciting proposals for the financing for the following equipment for the Public Works Department: two chassis (\$213,174), two dump bodies (\$88,980), two material spreaders (\$55,778), two snow plows (\$15,390) and on single axle chassis with post puller and aerial work platform (\$230,521). The total financed will be \$603,843.00 for a period of thirty six (36) months. Interest rates must be fixed and payments should be calculated based on a thirty six month period. Loan closing will be approximately September 5, 2014 with the first payment due 30 days after. Financing must be a regular bank loan/promissory note and not a lease/purchase agreement. **This loan will be bank qualified under Section 265 of the Internal Revenue Code of 1986.**
