WHEREAS, the levies of the Papillion Rural Fire District and the Good Luck Fire District been certified to the Sarpy County Clerk as required by Neb. Rev. Stat. § 13-508(2) (2012 Supp.); and,


WHEREAS, the Papillion Rural Fire District and the Good Luck Fire District City have delivered to the County Clerk a request to change to the property tax request and the County Board of Equalization must act on said request by no later than October 15, all as required by 77-1601.02; and,



NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF EQUALIZATION the taxes for the fiscal year 2014-2015, are hereby levied at the rate set on the attached Exhibit "A." The tax levy for the other various political subdivisions having been set by previous action of this Board.

BE IT FURTHER RESOLVED that the County Clerk provide a certified copy of this resolution to the Sarpy County Assessor for proper transcribing of such levy.
