WHEREAS, pursuant to Neb. Rev. Stat. §23-104 (Reissue 2012), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,


WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2012), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, an agreement was approved on January 10, 2012, see Resolution 2012-6, by which Alegent Health agreed to provide certain care, treatment, evaluation, safekeeping and assessment of juveniles under the control of the Sarpy County Juvenile Court, which agreement was extended commencing January 1, 2013 through December 31, 2013, see Resolution 2013-22; and,


WHEREAS, Alegent Health has the expertise and ability to provide such services and it is in the best interests of the citizens of Sarpy County and those under the control of the Sarpy County Juvenile Court to extend the health care agreement with Alegent Health for a one year term commencing January 1, 2014 through December 31, 2014, per the attached amendment agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS THAT the Chairman of this Board, together with the County Clerk, is hereby authorized to execute on behalf of this Board the Amendment Agreement for the provision of certain care, treatment, evaluation, safekeeping and assessment of juveniles under the control of the Sarpy County Juvenile Court with Alegent Health for the term commencing January 1, 2014 through December 31, 2014 , a copy of which is attached, and any other related documents, the same being approved by the Board.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 7th day of January 2014.

In 2012, Sarpy County entered into an agreement with Alegent Creighton Health for the care and treatment, including inpatient psychiatric evaluations, of juveniles under the control of the Sarpy County Juvenile Court. These services are charged to the County at Medicaid negotiated rates and the County has only utilized these services a few times in the past few years with invoices totaling less than \$462.00.

AMENDEMENT

THIS AMENDMENT is entered into by and between the County of Sarpy, Nebraska, a political subdivision of the State of Nebraska, hereinafter referred to as "Sarpy County", and Alegent Creighton Health, hereinafter referred to as "Alegent Creighton Health".

WHEREAS, the parties entered into an Agreement executed by Sarpy County effective January 1, 2012, attached hereto and incorporated by this reference, for the care treatment, evaluation, safekeeping and assessment of juveniles under the control of the Sarpy County Juvenile Court by Alegent Creighton Health; and

WHEREAS, the original term of the Agreement is from January 1, 2012 to December 31, 2012 and has the option to renew for one (1) year periods upon expressed written consent of both parties; and

WHEREAS, the parties wish to renew the agreement for an additional one (1) year term beginning January 1, 2014 and ending December 31, 2014.

NOW, THEREFORE, in consideration of the mutual covenants contained in the attached Agreement and stated herein the parties agree as follows:

1. The Agreement shall be renewed for an additional one (1) year term beginning January 1, 2014 and ending December 31, 2014.
2. All other terms of the Agreement, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
