RESOLUTION AUTHORIZING CHAIRMAN TO SIGN CONTRACT CHANGE ORDER TO THE
AGREEMENT WITH QWEST COMMUNICATIONS COMPANY, LLC
FOR THE PURCHASE AND INSTALLATION OF EQUIPMENT
FOR THE SARPY COUNTY EMERGENCY MANAGEMENT AND COMMUNICATIONS DEPARTMENT

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6) (Reissue 2007), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103 (Reissue 2007), the powers of the County as a body are exercised by the County Board; and,

WHEREAS, Sarpy County (hereinafter "County") and Qwest Communications Company, LLC (hereinafter "Qwest"), have entered into an agreement dated August 30, 2011 for the purpose of purchasing and installing certain equipment as ordered by the Federal Communications Commission; and,

WHEREAS, certain equipment was unintentionally omitted from the original agreement; and,

WHEREAS, a Contract Change Order is needed to add the omitted equipment to the agreement; and,

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the Chairman of this Board is authorized to sign the attached Contract Change Order modifying the equipment and associated costs for the VIPER upgrade.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 19th day of June, 2012.

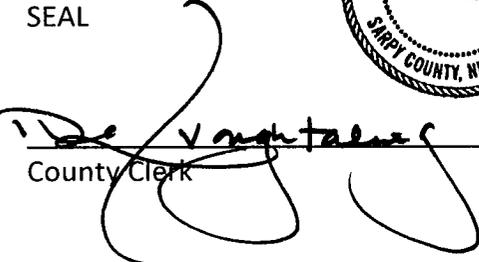
