WHEREAS, additional work was identified in Change Order #001 for \$8,352.00; and,

WHEREAS, additional work has been identified in Change Order #002 for \$1,985.00, as attached.

NOW, THEREFORE, BE IT RESOLVED, By the Sarpy County Board of Commissioners, that the attached Change Order #002 in the amounts listed is approved.


