RESOLUTION REJECTING BIDS FOR TWO (2) STAINLESS STEEL MATERIAL SPREADERS

WHEREAS, pursuant to Neb. Rev. Stat. §23-104(6), the County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. §23-103, the powers of the County as a body are exercised by the County Board; and,

WHEREAS, bids for two (2) stainless steel material spreaders have been solicited, made, opened and reviewed pursuant to applicable Nebraska State Statutes; and,

WHEREAS, based on those proceedings, and after a public hearing, this Board has duly deliberated and considered the bids received; and,

WHEREAS, permission to re-solicit bids has been requested; and,

NOW, THEREFORE, BE IT RESOLVED pursuant to Neb. Rev. Stat. §23-108 and Neb. Rev. Stat. §39-810 that the Sarpy County Board of Commissioners hereby finds and determines that the bids for the purpose set forth above be and hereby are, rejected with permission being request to rebid the project. The Clerk of the County is hereby directed to notify the bidder of this Board's action, to return the bid bonds posted herein, if necessary, and to take such other steps as may be necessary to effectuate the rejection of the offered bids.



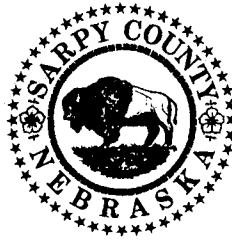



Re: Reject Bids for Spreaders

On July 9, 2015, two (2) bids were opened for two (2) stainless steel material spreaders for the Public Works Department. In reviewing the bids, discussions with dealers and discussions with the Henke manufacturer, it was noted that Henke restricted quotes to only one dealer. Henke confirmed that they would provide quotes to other dealers if we removed the installation component. Therefore, we recommend rejecting the bids and rebidding the project with Sarpy installing the spreaders instead of the selected dealer. George Funderburk, Fleet Services Manager, is confident the County is capable of installation.
