WHEREAS, this Board desires to proceed forthwith in order to expedite and facilitate service to the citizens of Sarpy County.


NOW, THEREFORE, BE IT RESOLVED BY THIS BOARD OF COUNTY COMMISSIONERS THAT:

- (1) Based upon the recommendation of the Purchasing Department, and upon a comparison of the bids to the bid specifications, the bid is hereby awarded to the lowest responsible bidder Northern Truck Equipment Corp. for Two (2) Stainless Steel Material Spreaders in the amount of Forty Nine Thousand Five Hundred Eighty Four Dollars and No Cents (\$49,584.00) is accepted, ratified, and confirmed.
- (2) This Board's Chairman, Clerk, and Attorney are hereby authorized and directed to execute such ancillary documents as may be required to evidence the contract and take any and all steps necessary or required in order to carry out the terms of such contract after said documents have been reviewed by the Attorney, Fiscal Administrator, and County Administrator.

The above resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 18th day of August, 2015.

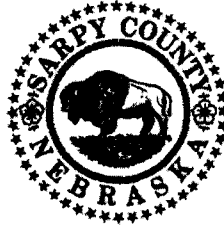

Notice to Vendors

Sarpy County is seeking proposals for Two (2) Stainless Steel Material Spreaders for the Public Works Department. **Sarpy County will be installing the Two (2) stainless Steel Material Spreaders. This proposal does not include installation.**

Sealed bids will be received Monday through Friday 8:00 a.m. to 4:45 p.m. except holidays, until 2:00 p.m., Thursday August 6, 2015. Bids shall be in a sealed envelope, clearly marked "Sealed Bid – Two (2) Stainless Steel Material Spreaders" and shall have the name of the Vendor, and the time and date of the bid opening. **Do not fax bids, only sealed bids will be accepted.**

Requests for information and clarification questions must be received by July 30, 2015 at 12:00 P.M. in order for Sarpy County to have time to issue an addendum.

Vendors that obtain specifications from the internet sites are responsible for obtaining any addenda that may be added at a later time.

Bids not addressed and delivered to the above person will not be considered. Bids received after the above stated time and date will not be considered.

Bid opening will be a public opening to be held in the Sarpy County Conference Room located at 1210 Golden Gate Drive, Papillion, NE. The bid opening will be at 2:00 p.m., Thursday, July 9, 2015.

All bids submitted shall be valid for a period of ninety (90) days following the final date for submission of bids.

Sarpy County will not be liable for costs incurred by Vendors for proposal preparation, printing, demonstration, or any other costs associated with or incurred in reliance on proposal creation. All such costs shall be the responsibility of the Vendor.

The bids shall include all charges and applicable taxes, F.O.B. Destination, freight prepaid, Sarpy County, Nebraska. The Vendor need not include sales tax in the bid. Sarpy County will, upon request, furnish the successful Vendor with a completed State of Nebraska Tax Exempt Form 13 upon acceptance of the successful Vendor's proposal.

The Sarpy County Board of Commissioners reserves the right to reject any or all bids and to waive minor informalities.

In the event of conflict between unit price and extended price, unit price shall prevail.

Procedures for Evaluation and Awarding of Bid

Evaluation will be done by Beth Garber, Sarpy County Purchaser along with personnel from the Public Works Department and Fleet Management Department. After evaluation the Purchaser will make a recommendation to the County Board of Commissioners for award. This recommendation and pending award will be made at a public meeting of the Board of Commissioners. Agendas are available each Friday afternoon on our internet site www.sarpy.com. The Commissioners award the bid by majority vote.

The following factors will be used to consider the award of the bid, where applicable:

- a) Compliance with all requirements.
- b) Price.
- c) The ability, capability, and skills of the Vendor to perform.
- d) The character, integrity, reputation, judgment, experience, and efficiency of the Vendor.
- e) The quality of previous performance.
- f) Whether the Vendor can perform within the time specified.
- g) The previous and existing compliance of the supplier with laws.
- h) The life-cost of the personal property or services in relation to the purchase price and specified use.
- i) The performance of the personal property or service taking into consideration any commonly accepted tests and standards of product, service, usability and user requirements.
- j) The energy efficiency ratio as stated by the supplier.
- k) The life-cycle costs between alternatives for all classes of equipment, the evidence of expected life, the repair and maintenance costs, and the energy consumption on a per year basis.
- l) Such other information as may be secured having a bearing on the decision.

Terms and Conditions

1. Information, Discussion, and Disclosures

Any information provided by Sarpy County to any Vendor prior to the release of this Request for Proposal ("RFP"), verbally or in writing, is considered preliminary and is not binding on Sarpy County.

The Vendor must not make available nor discuss any cost information contained in the sealed copy of the proposal to or with any employee of Sarpy County from the date of issuance of this RFP until the contract award has been announced, unless allowed by the Sarpy County Purchasing Department in writing for the purpose of clarification or evaluation.

No interpretation of the meaning of the specifications, or other bidding documents, or correction of any ambiguity, inconsistency, or error therein will be made orally to any Vendor.

Every request for such interpretation or correction should be in writing, addressed to the Sarpy County Purchaser, Beth Garber, 1210 Golden Gate Drive Suite 1220, Papillion, NE 68046 or bgarber@sarpy.com. **Requests must be received by 12:00 p.m., July 30, 2015 in order for Sarpy County to have time to issue an addendum. Requests received after deadline may not be considered.** In case Sarpy County finds it expedient to supplement, modify, or interpret any portion of the bidding documents prior to the proposed bid date, such procedure will be accomplished by the issuance of written addenda to the RFP which will be mailed or delivered to all prospective Vendors at the respective addresses furnished for such purpose.

2. Addenda

All addenda will become part of this RFP and must be responded to by each Vendor.

All addenda must be acknowledged in writing in the bid submitted by the Vendor.

This RFP, any subsequent addenda, and any written responses to questions take precedence over any information previously provided.

3. Confidentiality of Documents

Sarpy County considers all information, documentation and other materials requested to be submitted in response to this proposal to be of a non-confidential and/or non-proprietary nature and therefore shall be subject to public disclosure under Neb. Rev. Stat. § 84-712.05(3).

Vendors are hereby notified that Sarpy County strictly adheres to all statutes, court decisions, and opinions of the Nebraska Attorney General with respect to disclosure of RFP information.

Any "proprietary, trade secret, or confidential commercial or financial" information must be clearly identified, in a separate sealed envelope, at the time of bid/proposal submission. **Pricing information is not considered financial information and therefore is not considered Confidential.** Please note: even if Vendor believes pricing information is confidential and includes it in a separate, sealed envelope, such information will be read aloud and entered into record during the public bid opening. For all other appropriately identified proprietary, trade secret, or confidential commercial or financial information, the Vendor will be required to fully defend, in all forums, Sarpy County's refusal to produce such information; otherwise, Sarpy County will make such information public upon request.

4. Non-Discrimination Clause

Pursuant to Neb. Rev. Stat. §73-102 (Reissue 2009), Vendor declares, promises, and warrants it has and will continue to comply fully with Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C.A. §1985, et seq.), and the Nebraska Fair Employment Practice Act, Neb. Rev. Stat. §48-

1101, et seq. (Reissue 2010), in that there shall be no discrimination against any employee who is employed in the performance of this Contract, or against any applicant for such employment, because of age, color, national origin, race, religion, creed, disability or sex.

5. Conflict of Interest Clause

Pursuant to Neb Rev. Stat. §23-3113 (Reissue 2012), the parties hereto declare and affirm that no officer, member, or employee of the County, and no member of its governing body, and no other public official of the County who exercises any functions or responsibilities in the review or approval of the undertaking described in this Contract, or the performing of services pursuant to this Contract, shall participate in any decision relating to this Contract which affects his or her personal interest, or any corporation, partnership, or association in which he or she is directly or indirectly interested; nor shall any employee of the County, nor any member of its governing body, have any interest, direct or indirect, in this Contract or the proceeds thereof.

6. Payment Terms

The successful Vendor shall submit an itemized invoice for payment. Sarpy County will make payment to the successful Vendor within thirty (30) days after receipt of invoice and satisfactory delivery.

7. Supplemental Terms and Conditions/Modifications

Any supplemental terms, conditions, modifications, or waiver of these terms and conditions must be in writing and signed by the Sarpy County Board Chairman and the Vendor.

8. Termination

Either party may terminate the Contract with ninety (90) days' written notice to the other.

9. Residency Verification

The Vendor agrees to comply with the residency verification requirements of Neb. Rev. Stat. §4-108 through §4-114. The Vendor is required and hereby agrees to use a federal immigration verification system to determine the work eligibility status of new employees physically performing services within the State of Nebraska. A federal immigration verification system means the electronic verification of the work authorization program authorized by the Illegal Immigration Reform and Immigrant Responsibility Act of 1996, 8 U.S.C. 1324a, known as the E-Verify Program, or an equivalent federal program designated by the United States Department of Homeland Security or other federal agency authorized to verify the work eligibility status of a newly hired employee.

If the Vendor is an individual or sole proprietorship, the following applies:

The Vendor must complete the United States Citizenship Attestation Form, available on the Department of Administrative Services website at www.das.state.ne.us.

- a) If the Vendor indicates on such attestation form that he or she is a qualified alien, the Vendor agrees to provide the U.S. Citizenship and Immigration Services documentation required to verify the Vendor's lawful presence in the United States using the Systematic Alien Verification for Entitlements (SAVE) Program.
- b) The Vendor understands and agrees that lawful presence in the United States is required and the Vendor may be disqualified or the contract terminated if such lawful presence cannot be verified as required by Neb. Rev. Stat. Sect. 4-108.

10. Breach

Should Vendor breach, violate, or abrogate any term, condition, clause or provision of this agreement, the County shall notify Vendor in writing that such an action has occurred. If satisfactory provision does not occur within ten (10) days from such written notice the County may, at its option, terminate this agreement and obtain an alternate provider to provide all required materials. This provision shall not preclude the pursuit of other remedies for breach of contract as allowed by law.

11. Assignment

The Vendor may not assign this Contract without the prior written consent of the County.

12. Subcontracting

Vendor may not subcontract the work to be performed, without prior written consent of the County. If such consent is granted, Vendor will retain responsibility for all work associated with the Contract. The Vendor must identify any subcontractors it intends to use in the execution of this Contract. The Vendor must identify subcontractors in writing within the proposal.

13. Independent Contractor

The Vendor shall in the performance of the Contract at all times be an independent contractor and not an employee or agent of the County. The Vendor, its officers, employees and agents shall at no time represent the Vendor to be other than an independent contractor or represent themselves to be other than employees of the Vendor.

14. Indemnity

The Vendor shall indemnify and save harmless Sarpy County, its officers, employees and agents from all loss, claims, suits or actions of every kind and character made upon or brought against

Sarpy County, its officers, employees, or agents, for or sustained by any party or parties as a result of any act, error, omission or negligence of said Vendor or its servants, agents, and subcontractors; and also from all claims of damage in fulfilling this Contract.

15. Deviations

Once the bid has been accepted by Sarpy County, no deviations from the specifications will be accepted without prior written approval of Sarpy County.

16. Exceptions

These specifications are minimum acceptable specifications. You may bid other than what is specified if it is of higher specification than what is requested. Vendor must list any exceptions to the bid specifications on the bid form.

17. Literature

Vendor shall attach one (1) set of detailed specifications or advertising literature of systems to the bid form. Any information necessary to show compliance with these requirements not given on the attached advertised data sheets shall be supplied in writing and attached to the bid proposal. Lack of sufficient information supplied with a proposal is cause for automatic rejection of such bid.

18. Warranty

A copy of all manufacturer's warranties shall be included in Vendor's proposal.

The Vendor shall warrant all materials, workmanship and equipment against defects for a period of one year beginning on the date of substantial completion except that certain equipment shall be warranted for longer periods as described in manufacturer's warranties.

19. Company Information

Vendor will provide the following company information on the bid form:

- a. Years in business;
- b. Number of employees; and,
- c. Total sales for last three (3) years.

20. Tobacco Free Notice

The use of tobacco is not permitted within the facilities or on the property of leased and owned Sarpy County buildings at any time including, but not limited to lawns, sidewalks, parking lots and vehicles on authorized County business.

21. References

Each Vendor must include with its proposal a list of no less than three (3) current references that have purchased the specified product or service within the last two (2) years. The list must include the name of the company along with the name, phone number, and email of a contact person for each company.

22. Delivery

Vendor shall provide delivery time frame to Sarpy County with the bid.

YES/NO

A. Hopper Body:

- 1. The body shall be made of 304 stainless steel construction, 201 stainless steel is not acceptable.
- 2. Inside body length of 13 feet (13').
- 3. Overall height with top extension shall be sixty-four inches (64").
- 4. Minimum eleven (11) cubic yard capacity struck. If necessary, a hopper extension may be used to provide eleven (11) cubic yard water level capacity.
- 5. Width of hopper shall be eighty-two inches (82").
- 6. The body sides of the hopper shall be a minimum of forty-five (45) degree pitch for easy flow of material to conveyor belt.
- 7. Hopper body sides shall be a minimum of 10GA 304SS.
- 8. Hopper body longsills shall be a minimum of 7GA 304SS
- 9. Distance from outside to outside across longsills shall be a minimum of 31.25" inches.
- 10. Front and rear body panels shall be sloped in at eighteen (18) degree and ten (10) degree respectively.
- 11. Integral 2.0" x 1.0" channel shall be formed into top edge of side and end body panels.
- 12. Side supports (ribs) shall be spaced on twenty-four inch (24") centers over the full length on both sides of the hopper.
- 13. Cross sills shall be comprised of formed 3.0" x 1.5" formed 7GA 304SS.

- 14. Ribs shall be welded to the hopper sides and cross sills.
- 15. Four braces .25" thick shall be provided. One brace shall be placed in each upper corner of the hopper.
- 16. There shall be four (4) dual purpose lifting / tie down loops furnished on the corners of the hopper body. The front mounting loops shall be used to secure the sander into the box.
- 17. Longsills shall have opening reinforced with 2.00"x2.00"x.250" 304SS square tubing for the purpose of retaining the cartridge in its stowed position.
- 18. The base flange of the longsills shall contain a ramp and platform for the purpose of stowing the cartridge at the front most end of the longsills on both sides.
- 19. Stow platform to be a minimum eleven inches (11") long and made of 7GASS construction.
- 20. Four steel roller wheels shall be mounted in the base flange of the longsills at a thirty (30) degree from horizontal for the cartridge to roll on when being stowed and removed.
- 21. Roller wheels shall not be bearing load while spreader is in operation.
- 22. Roller wheels shall be 3.0" inches in diameter with a 1/2" ID press fit graphic impregnated bronze bushing.
- 23. Roller wheels shall have a brass washer to separate it from its rotating surface.

B. Conveyor:

- 1. Conveyor shall be capable of engaging material along its full length to move material to the rear of sander.
- 2. Conveyor shall be single auger type.
- 3. Auger drive motor to be mounted at the rear, direct drive only.
- 4. Auger drive motor shall be equipped with a safety lock out valve.
- 5. All conveyor components shall be contained within a cartridge comprised of separate longsills from those attached to the hopper.

- X/___ 6. Cartridge shall be removable from the hopper and when stowed in the hopper, cartridge longills shall be internal to the hopper longills.
- X/___ 7. Cartridge shall contain (4) four 1.50"OD 1.00"ID 304SS bushings to be used for the purpose of securing the cartridge into the hopper and attaching the cartridge legs.
- X/___ 8. Cartridge longills to be minimum 7GA 304SS construction.
- X/___ 9. Cartridge longills to include integral chain shields.
- X/___ 10. Distance from inside to inside across cartridge longills to be a minimum of 29.75" inches.
- X/___ 11. Bearing flange of cartridge longills to be at 30 degree from horizontal and have an additional vertical flange support.
- X/___ 12. Front base flange to have added "U" shaped stiffener minimum 10.0" long.
- X/___ 13. Cartridge longills shall have a reinforced ramp and bearing platform located underneath the bearing flange at the rear of the cartridge of 7GA 304SS construction.
- X/___ 14. Bearing platform shall be configured to hang the spinner chute from and contain a pull bar for the purpose of stowing and removing cartridge from hopper.
- X/___ 15. Pull bar shall be 2.00" x 2.00" x .250" 304SS square tubing with handles and 1.0" diameter through hole.

C. Discharge Gate:

- X/___ 1. An adjustable discharge gate shall be formed of 7GA 304SS. The adjustable discharge gate shall be equipped with a hand - crank screw jack. This will be used to properly adjust the flow of material to the spinner. Maximum feed gate opening shall be approximately eleven inches (11") high and twenty inches (20") wide. Heavy duty, replaceable, "bolt-on" shall be made of 304SS feed gate slides will reinforce the gate opening. All necessary hardware shall be made of 304SS. To provide accurate calibration of the material flow, a feed gate indicator and ruler shall be provided.

D. Spinner, Chute Assembly

- X/___ 1. The upper chute portion shall slide internal to the lower spinner assembly and have a minimum 24.0" by 13.0" square opening to prevent clogging and fouling in the chute.
- X/___ 2. The upper chute made of 304SS shall include a dump over chute that can be positioned in such a manner that material can be unloaded from the spreader without striking the spinner.

X/ 3. Spreader chute shall be vertically adjustable a minimum of nine inches (9") in three inch (3") increments.

X/ 4. Spinner motor to be directly coupled to and mounted above the spinner.

Specify type: WHITE - 200050F3105AAAA

X/ 5. The spinner disc shall be made of 304SS twenty inches (20") in diameter. The spinner disc shall rotate **counter clockwise** as viewed from the top or hydraulic motor side. The spinner disc assembly shall be designed to obtain a controlled spread.

X/ 6. Material should be guided from conveyor to spinner disk by two (2) internal baffles that are externally adjustable without the use of tools.

X/ 7. External adjustments shall double as safety guards not allowing any part of the operator's body to pass into the chute from the side.

X/ 8. Spread pattern shall be adjustable from six (6') to forty feet (40') using the six (6) 10GA 304SS baffles.

X/ 9. After discharge the material shall be guided to the ground by four (4) external baffles three of which are adjustable without the use of tools. The shields will be designed to prevent material from exiting the corners of the spinner and striking the underside of the truck or trailing vehicle. Baffle sections made of 304SS.

X/ 10. Spinner assembly rear base plate to be angled away from hydraulic spinner motor at a minimum of thirteen (13) degrees to allow material and moisture to shed away from the spinner motor.

X/ 11. Spinner motor shall have a displacement of 3.2 cubic inches per rev minimum.

H. Power Drive:

X/ 1. Two (2) hydraulic motors, one powering the spinner and one the auger. Motors shall be of the highest quality on the market.

Specify make/model of spinner motor:

WHITE - 200050F3105AAAA

I. **Inverted "V":**

- X/ 1. A height adjustable ten (10) gauge 304SS inverted "V" steel shield supported from a minimum of two vertical positions shall be provided to reduce the load on the conveyor. This "V" shall be designed to allow a swing motion to eliminate material bridging while protecting the conveyor from excessive load pressure.

J. **Cab Shield:**

- X/ 1. Cab Shield shall be designed to protect the cab and front area of dump body from falling material. It shall be 82"X 24" with a slope down design so that material landing on it will fall into the hopper as the spreader unloads. The cab shield shall be constructed of a minimum of twelve (12) gauge 304SS.

K. **Screens:**

- X/ 1. Screens shall be of the heaviest steel used by the manufacturer. The screen sections are to have 1/2" diameter rod welded to a 1/2" x 2" flat bar frame forming 2-1/2" x 2-1/2" openings. Tanks shall be baffled with two (2) 1 1/4" outlet ports. Pre-Wet pump shall be driven by the exhaust oil from the Spreader conveyer drive motor. Spinner drive motor exhaust oil must be tied into the return line after the pre-wet pump to prevent the pump from running when the spinner is on. The Pre-wet pump shall have a minimum capacity of seven (7) GPM. Pump assembly and control components shall be mounted in a stainless steel weather tight enclosure.

Enclosure shall be constructed from corrosion-resistant material. All plumbing components shall be black, glass reinforced polypropylene with black EPDM hose rated at 150 PSI. Pre-wet system shall incorporate in-line check valves, shut-off valves, in-line screen strainer, and low level indicator light. All mounting plates and hardware will be made of 409 stainless steel. All components shall be corrosion-resistant throughout. Minimum of three (3) variable displacement spray orifices shall be installed on the back of the sander above the auger on a stainless steel rod bolted to both sides of the sander. Pre-wet system shall be controlled by electronic controls provided by Sarpy County.

T. Operation, Parts and Maintenance Manuals:

1. These manuals shall cover the safe operation, maintenance, and parts listing for the units.
