WHEREAS, based on those proceedings, this Board has duly deliberated and considered the bids received; and,



WHEREAS, permission to re-solicit bids has been requested; and,

The Clerk of the County is hereby directed to notify the bidder of this Board's action, to return the bid bonds posted herein, if necessary, and to take such other steps as may be necessary to effectuate the rejection of the offered bids.
